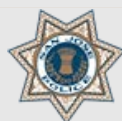

### **SJPD Joins Effort to Deploy 2 of 300 Sobriety Checkpoints over the Holidays**

The holiday season is upon us. Plans are in place for parties, shopping and traveling to friends and family. However, each year motorists will be in harm's way thanks to the careless ones who will drink and drive this season.

Beginning Wednesday, December 16, 2009, San Jose Police Department will join law enforcement across the state as part of California's 18 Day Holiday DUI Crackdown Campaign with law enforcement agencies deploying 300 DUI/Drivers License Checkpoints statewide. Funding for the special enforcement campaign, December 16, 2009 through January 3, 2010 comes from a grant from the California Office of Traffic Safety(OTS) through the National Highway Traffic Safety Administration.

A combination of DUI checkpoints and saturation patrols will be utilized throughout this period to ultimately reduce the amount of injuries and deaths that occur due to impaired driving.

In 2008, 11,773 people died in highway crashes involving a driver or motorcycle rider with a blood alcohol concentration (BAC) of .08 or higher. In California 1,029 were killed on state and local roads driving with a .08 BAC or higher with another 28,457 injured in Alcohol Involved Collisions.

"Drunk driving is simply not worth the risk. Not only do you risk killing yourself or someone else, but the trauma and financial costs of a crash or an arrest for impaired driving can be significant," said Christopher J. Murphy, Director of the California Office of Traffic Safety. "Violators often face jail time, the loss of their driver's license, higher insurance rates, attorney fees, time away from work, and dozens of other expenses. So don't take the chance. Remember, if you are over the limit, you are under arrest."

Law enforcement encourages everyone planning a family gathering over the holidays to first think about how your friends and family will get home after drinking holiday celebrations. Everyone is encouraged to "Report Drunk Drivers-Call 911" and be ready to describe the vehicle, its location and direction of travel to make your community safer into the New Year. With everyone's help, families won't remember the holidays of 2009 as a time of loss at the hands of another drunk driver.

On Wednesday, December 9, 2009, at approximately 8:15 AM, San Jose Police officers responded to a Suspicious Circumstance call that occurred in front of Ida Price Middle School, located at 2650 New Jersey Avenue in San Jose. An 11 year-old boy was approached by a blond female adult, driving a red sport utility vehicle. The adult female attempted to lure the juvenile into her vehicle but he refused. She then drove away. The suspect was described as a White female adult with long blond hair (mid-back), pony tail, wearing Black rimmed glasses. She was described as chubby or heavy set.

On Friday, December 11, 2009, at approximately 12:40 PM, San Jose Police officers responded to another Suspicious Circumstance call that took place in front of Galarza Elementary School, located at 1610 Bird Ave. A 3 year-old boy was approached by a White female adult, who was on foot. The child's mother saw the female suspect talking to her son and the mother called out the son's name. The female fled in a Tan colored sedan. The suspect was described as a White female adult, in her mid to late 30's, with blond, long, wavy hair (mid-back). The female suspect was approximately 5'10 to 6'0, weighing 140 to 150 pounds and wearing a Tan colored rain coat.

These schools are approximately 3 miles apart. It has not been confirmed that these cases are related at this time.

In May 2009, San Jose Police Burglary Investigators notes a series of night time commercial burglaries, in which the victims were small retail businesses. 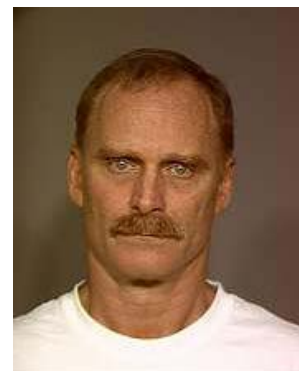

On September 3, 2009 at 7:53 PM, officers responded to an address in the 100 block of South 23rd Street in San Jose. An individual called police advising that a roommate had brandished a knife at another roommate and threatened him. Upon arrival, officers reported having a difficult time gaining the cooperation of the suspect as they attempted to take him into custody. The suspect was ultimately taken into custody with the use of a baton and an electronic restraint device. Per Department policy, a supervising Sergeant responded to the scene. Officers summoned an ambulance to assist in the transportation of the suspect to a local hospital, where he received medical treatment prior to being booked on charges of Brandishing a Weapon, Assault and Battery, and Resisting Arrest. The District Attorney subsequently charged the suspect with Brandishing a Weapon and Resisting Arrest.

On Thursday, October 22, 2009 a reporter from the Mercury News contacted Sgt. Ronnie Lopez, the SJPD Press Information Officer, and provided a copy of a video depicting a portion of the arrest of the suspect by SJPD officers. The video apparently had been taken by a roommate of the suspect who was in the apartment at the time of the suspect's arrest.

Upon viewing the video, SJPD Command Staff immediately launched a probe into the incident to determine exactly what took place during the interaction with the officers. Detectives from the Detective Bureau have been working the case since that time. Per Department policy, investigators from the Internal Affairs Unit have been monitoring the investigation. Upon completion of the investigation, the case will be reviewed by the District Attorney's Office to determine if they need to take any action.

Led by the Internal Affairs Unit, an administrative investigation will then be conducted by the Department to determine if the actions of the involved officers were in accordance with the Department's policies and procedures. Officers would be subject to discipline should they be found to be out of compliance with Department policy. The administrative review also allows the Department the opportunity to determine whether or not changes need to be made in its policies, procedures and/or training.

The Department takes great pride in its proactive efforts to maintain the highest standards of conduct from its officers. The Department encourages anyone who has a complaint or concern about any officer to bring it forward to the Departments Internal Affairs Unit at (408) 277-4094 or to the Office of the Independent Police Auditor at (408) 794-6226.

It should be noted that the Department is in the process of embarking on a pilot program in which a test group of officers will be equipped with a device that employs new technology allowing them to capture both video and audio recordings of their actions in the field. This small device is worn on their person. This program will make the Department the first police agency in the nation to test

these new devices.

#### DETAILS:

Between July 2008 and July 2009, more than 6,500 vehicles were stolen in San Jose, and each year, along with the arrival of the cold winter weather comes a marked increase in "warm up" vehicle thefts.

"Warm ups" typically occur when the owner starts the vehicle to warm the interior, and then leaves it running and unoccupied while he or she goes back inside the residence. When the owner returns, the vehicle is gone. In many cases, the vehicle is stolen right out of the owner's driveway. Locking the doors while leaving the engine running is often not effective as thieves simply break a window to gain entry and steal the vehicle. With the onset of winter weather, the San Jose Police Department strongly advises against leaving your vehicle unoccupied with the engine running.

Here are some other vehicle theft prevention tips:

- Whenever possible, park your car inside a locked garage or in a well-lighted area.
- When leaving your vehicle, close all windows, lock the doors and take the keys with you.
- Consider installing an anti-theft device or alarm system.
- Remove all valuables from the vehicle or place them out of sight of thieves

For most people, their vehicle is their second most valuable possession. Following a few simple precautions can help minimize the chances of losing your car, truck or SUV to a thief.

As the victim returned to his car, the suspect approached from behind and demanded his wallet. When the victim refused, the suspect stabbed the victim in the chest with a long, hunting-style knife.

The knife was described as having a yellow / gold colored handle and a silver colored blade with a serrated edge. The victim attempted to defend himself from further attack, but was stabbed a second time.

During the struggle, the victim's wallet fell to the ground. The suspect picked up the victim's wallet, took two (2) cellular telephones from inside the victim's vehicle, and fled towards Alum Rock Avenue.

The suspect is similar to the composite sketch and was described as an Hispanic male adult, 24-25 years old, 5'8" tall, 170-180 lbs., with short brown hair, and was last seen wearing a black cap, dark jacket, and denim jeans.
