#### San Jose:

On June 1, 2010, approximately 7:00 a.m., the San Jose Police Department's Traffic Investigations Unit served search warrants in San Jose and Los Banos, related to the August 30, 2008 fatal hit-and-run collision that occurred in downtown San Jose. Along with other potential evidence, the two-year investigation resulted in officers recovering a dark blue 1994 Toyota 4-Runner sports utility vehicle, believed to have been involved in the collision.

Police arrested 46-year-old Los Banos resident, Manuel Ramirez Ramos, and charged him with being the driver of the vehicle involved in the hit-and-run collision. Police also arrested 50-year-old San Jose resident, Juan Ahumada Solorzano, the registered owner of the Toyota 4-Runner, for aiding Ramos conceal evidence of the crime.

Ramos was a resident of San Jose at the time of the collision and is the brother-in-law of Solorzano. Ramos and Solorzano were booked into the Santa Clara County Jail.

The San Jose police would like to thank members of the public for coming forward and providing information that led to the arrests and recovery of the evidence.

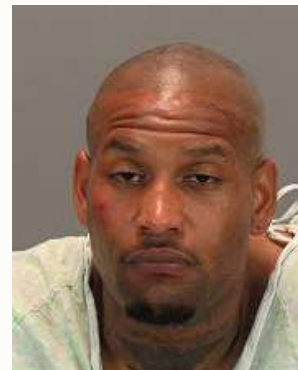
**San Jose:** On Friday, May 28th, 2010, San Jose Police officers arrested Russell Edward Garcia following an investigation into a string of armed robberies in San Jose.

The first incident occurred on Monday, May 17th, 2010 at approximately 10:45pm when a person delivering a pizza in the 200 block of N. 19th St. was robbed by a male suspect and his accomplice. The male, later identified as suspect Garcia, displayed a firearm and demanded money. The victim complied and the suspects fled. The victim was not injured.

The second incident occurred on Thursday, May 20th, 2010 at approximately 3:12pm. A taxicab was dispatched to the 800 block of E. St. James St. to pick up a fare. The cab driver picked up the fare, who was subsequently identified as Garcia's accomplice. The accomplice was taken to an address in the 400 block of S. 11th St., where the accomplice got out of the cab and walked to a residence. After the driver made a U-turn and parked the cab to wait for the accomplice's return, the suspect jumped in the back seat of the cab and pointed a firearm at the driver's head. Fearing for his life, the driver complied and the suspect fled. The driver was uninjured.

On Tuesday, May 25th at approximately 10:35pm, a taxicab was dispatched to the 300 block of N. 13th St. in San Jose. When the driver arrived, the suspect entered the back seat of the cab. While the cab was in motion, the suspect pointed a handgun at the driver's head and demanded cash. The suspect took the money and fled. There were no injuries.

The final incident occurred on Friday, May 28th at approximately 2:23pm when a taxicab was dispatched to pick up a fare in the





600 block of Novak Dr. in San Jose. After the suspect directed the cab driver to proceed to an undisclosed location, the suspect pointed a firearm at the driver and demanded cash. After robbing the driver, the suspect ordered him out of the cab and the suspect drove away in the vehicle. Officers located the unoccupied taxicab a few blocks away.

Following an investigation, San Jose Police Department robbery detectives identified Garcia as the suspect in these crimes and initiated a surveillance of a residence he was known to frequent. During the surveillance, Garcia was observed leaving the home. San Jose Police officers followed Garcia to the area of S. 7th St. and E. Reed St. in San Jose and attempted to take him into custody. The suspect ran from officers and was pursued by San Jose police canine "Rocco." During the apprehension, the suspect drew a gun from his waist area, pointed it at "Rocco" and pulled the trigger, but the weapon malfunctioned and did not fire. "Rocco" apprehended Garcia by pulling him to the ground; however, Garcia again pointed the weapon at the dog and pulled the trigger. Again, the firearm malfunctioned. Officers were able to subdue Garcia and safely take him into custody. In addition to committing the robberies, Garcia had multiple outstanding warrants was wanted for absconding from parole. He was treated for dog bite injuries at a local hospital and then booked into the Santa Clara County Jail. Detectives continue to investigate the possible involvement of others in these crimes.

#### **BUCKLE UP DAY AND NIGHT Seat Belt Ticket Increases to \$142**

**SAN JOSE:** If you're planning to hit the road for a late spring or early summer getaway, be sure that everyone in the car wears their seat belt on every trip, day and night. Law enforcement throughout the state, including San Jose Police Department will be looking for unbelted drivers and passengers as part of the 2010 Click It or Ticket mobilization, May 24-June 6. This year, fines and fees have increased from \$132 to \$142 for first-time adult seat belt violations. For children under 16, the fine is now \$445 for a first-time offense.

Keep your friends and family safe by buckling up no matter where you're going, said Police Chief Davis. We will be looking for motorists throughout the area who are not buckling up, day and night. It's not just about avoiding a ticket; it's about keeping the ones you care about alive.

Seat belt violators will receive citations, no warnings. The Click It or Ticket campaign relies on heavy enforcement and public education as a means to help save lives on California's roadways.

Wearing a seat belt is just simply the easiest and most effective thing you can do on the road to protect yourself and your family, said Christopher J. Murphy, Director of the California Office of Traffic Safety. That means buckling up day and night, on every trip.

More than 600 permanent Click It or Ticket highway signs, which have been up since 2005, will be updated to reflect the new minimum \$142 in the coming months.

Currently California has a seat belt usage rate of 95.3 percent, but that still means over half a million people are not buckling up. Properly restrained drivers, passengers and children have a 50 percent better chance of surviving a crash than unbelted occupants. Those ejected from vehicles in crashes or roll-overs are up to 35 times more likely to die than restrained occupants.

More than 150 local law enforcement agencies statewide and the CHP will be participating in this year's Click It or Ticket mobilization. Funding to support California's Click It or Ticket campaign was provided by a grant from the California Office of Traffic Safety through the National Highway Traffic Safety Administration.

#### **California's 2010 Click It or Ticket Seat Belt Enforcement Campaign Facts and Figures**

California's 2009 seat belt use rate is 95.3 percent. According to the National Highway Traffic Safety Administration (NHTSA), the national average in 2008 was 83 percent, a gain from 82 percent over 2007 (California Office of Traffic Safety (OTS) and NHTSA).

Since the Click It or Ticket campaign began in California in 2005, California's seat belt use rate has increased from 90.4 percent in

2004 to 95.3 percent in 2009. In the last four years alone, it is estimated that more than 1.25 million more motorists in the state have begun buckling up regularly (OTS).

According to the 2009 California seat belt use survey, Glenn County had the highest seat belt usage rate of the 39 counties surveyed at 97.7 percent, while Contra Costa County had the lowest seat belt use rate at 88.9 percent.

California's 2009 teen seat belt use rate is 91.1 percent, up slightly from the 2008 teen rate of 89.6 percent (OTS).

California's 2009 child safety seat usage rate is 90.9 percent a decrease from the 2008 rate of 94.4 percent (OTS).

The cost for a seat belt violation in California for unbuckled vehicle occupants over age 16 is \$142. (California Department of Motor Vehicles).

When children under age six are not properly secured in a vehicle, the parent or driver can receive one point on their driving record, in addition to a ticket of \$445 on a first offense. If the parent is not in the car, the driver gets the ticket (DMV).

California is one of 27 states with primary enforcement seat belt laws as of May 31, 2009 (NHTSA Center for Statistics and Analysis DOT HS 811 036).

#### San Jose Police Department Utilizes State of California Grant to Combat Underage Drinking

San Jose -The San Jose Police Department has been awarded grant funding for a program designed to combat alcohol-related problems in the city. San Jose and 14 other Northern California cities received the funding provided by the State of California Department of Alcoholic Beverage Control.

The San Jose Police Department utilized grant funds to conduct two recent operations aimed at reducing youth access to alcohol. On Saturday, March 13<sup>th</sup>, officers from the San Jose Police Department, the Department of Alcoholic Beverage Control and 14 other law enforcement agencies participated in a Shoulder Tap Decoy Operation.

Adult minors under the direct supervision of a peace officer stood outside convenience or liquor stores and asked adults to purchase alcohol for them. 109 citations were issued, including 81 to adults who agreed to purchase the alcohol after being advised the minor was under 21 years of age. The remaining 28 arrests involved other violations including illegal narcotics, being drunk in public, possession of an open container of alcohol and parole violations. In San Jose, the operation resulted in six citations for furnishing alcohol to a minor and two for possessing an open container of alcohol.

The second operation, conducted on St. Patricks Day, utilized adult decoys under 21 years of age in two different scenarios. First, the decoy entered an off-sale premises, which sells liquor for consumption off-site, and attempted to purchase alcohol. Clerks at two locations in San Jose were cited for selling alcohol to minors, while those at three other businesses refused to do so. The penalty for furnishing alcohol to a minor is a minimum \$1000 fine and 24 hours of community service.

Adult minor decoys also entered two on-sale establishments (such as a bar) and attempted to buy alcoholic beverages. At both businesses, the minors were asked for their identification and subsequently refused service.

San Jose Police Sergeant Heather Randol said the grant award allows the department to increase enforcement efforts and awareness of the problems surrounding youth alcohol consumption in the community.

The state's seat belt use rate in 2009 was 95.2 percent, which still leaves more than a million Californians vulnerable. Following an investigation by the San Jose Police Department, the Santa Clara County District Attorney's Office Elder Fraud Unit has issued a criminal complaint charging ex-Bank Manager John Tran, formerly of Wells Fargo Bank in San Jose, with several charges including Theft from an Elder, Grand Theft and Forgery.

From March 2008 to February 2009, Tran was a manager at Wells Fargo Bank on Lincoln Avenue in San Jose. Tran befriended several elderly clients, and even made visits to their homes. Unbeknownst to the clients, in February 2009 his employment with the bank ceased, yet he continued visiting some of the bank's customers. In some instances, Tran convinced elderly customers to invest in certain CDs, only to pocket the money himself through an elaborate money-laundering scheme. In other instances, Tran forged signatures of bank customers, including recently deceased senior citizens, and simply drained their bank accounts. Tran is alleged to have structured over \$900,000 in suspicious transactions. Tran was arrested on March 10, 2010.

#### DETAILS:

Since November of last year, the San Jose Police Department (SJPD) has been working with the Taser International Corporation as Taser has been designing a video/audio device that patrol officers could wear in the field to capture details of what is occurring as they handle calls for service. The device, known as the AXON device, is now ready to be deployed, and SJPD will be working with Taser on a pilot project to test the devices in the field. Eighteen SJPD officers have been trained on how to wear and use the AXON, and field deployment will begin tomorrow, December 18, 2009.

SJPD will become the first major city in the United States to deploy this technology, which has the potential of transforming how law enforcement officers will collect "best evidence" in the field for crimes in progress as well as assist in documenting officers actions.

On Friday, December 18, 2009, at 1:00 PM, SJPD will host a press conference at the department to provide additional details about how the devices will be used. Some of the uniformed officers who have been trained to use the AXON will be present at the press conference to demonstrate how the AXONs function. Members of the press will have access to interact one-on-one with these officers immediately following the formal press conference.

Traffic volume and weather permitting, all vehicles may be checked and drivers who are under the influence of alcohol and/or drugs will be arrested. Our objective is to send a clear message to those who are considering driving a motor vehicle after consuming alcohol and/or drugs Drunk Driving, Over the Limit, Under Arrest. The public is encouraged to help keep roadways safe by calling 911 if they see a suspected impaired driver.
