On 3/16/11, Hagan was arrested without incident near his home in South San Jose as a result of the investigation and booked into Santa Clara County Jail on seven felony counts of sexual acts against a 14- or 15-year-old child.

Hagan has been involved in the Oak Grove Youth Football League for 13 years. He currently remains in custody at the Santa Clara County jail on \$300,000 bail.

#### A LIFE WITHOUT VIOLENCE

The Consulate General of Mexico and the San Jose Police Department are proud to announce "A Life without Violence," a domestic violence informational session, on Thursday, March 24, beginning at 5:00 p.m.

The objective of this informational session is to inform our community about the prevention of this crime, which affects many immigrant women, and who are not aware that, as victims, they can obtain assistance just as any another member of our community.

It is vital that victims know they are protected by domestic violence laws in California, that they have the right to report this crime to the police, and that they can obtain help and utilize the womens shelters, call the rape crisis center, obtain victims assistance and request a restraining order.

Many women are affected by domestic violence and do not seek help for various reasons, one being fear of authorities in this, a foreign country to them.

This informational session will be comprised by experts in psychology and self-esteem, representatives of victims assistance

programs, media, and the San Jose Police Department.

"The San Jose Police Department recognizes the importance in maintaining the community's trust, which is why we are collaborating with the General Consulate of Mexico in San Jose, to combat domestic violence," said Officer Jose Garcia, of the San Jose Police Department.

As part of the informational session, San Jose police officers will be on hand to explain the various services available to residents who have been victims of domestic violence, regardless of their immigration status.

We appreciate the assistance from media outlets in broadcasting these planned activities, which will benefit our Mexican community and, in general, our entire Hispanic community.

**San Jose:** On 3/21/2011, at approximately 9:08 P.M., San Jose Police officers responded to the 4900 Block of Englewood Drive on a report of an at-risk missing person. Upon their arrival, they learned that the missing person, a 17 year old San Jose resident, was last seen at his grandmother's house on Englewood Drive. The victim is considered at-risk due to the fact that he has been diagnosed with Autism.

The preliminary investigation into the missing person revealed that the victim missed his Outreach bus after being let out of school at Nor Cal School located in the 400 block of Division Street in Campbell. Nor Cal staff provided the missing person with a ride to his grandmother's house on Englewood Drive. The missing person entered the residence, however his grandmother was not home. Later, the missing person's grandmother arrived home to find that he had left the residence without his backpack. The missing person has been described by his mother as being unwilling to speak freely, as well as possibly extremely depressed. According to members of the missing person's family, he is not capable of caring for himself and will not approach people for help. The missing person has gone missing on at least three previous occasions, and was found to be wandering the streets of San Jose.

This footage shows one of the armed suspects attempting to kidnap one of the victims. Detectives hope that the release of this footage may bring forward additional witnesses and/or information.

**San Jose:** The San Jose Police Department is investigating a triple homicide that occurred on Saturday, Jan. 8, 2011, at the Mexicali Club, 939 Oakland Road, in San Jose. Police received 9-1-1 calls at 8:27 p.m. of shots fired inside the bar. Three males reportedly entered the club while armed with firearms and a gun battle ensued.

The investigation reveals that three suspects, two of whom have been identified as Antonio Allon

and Manuel Barraza, entered the bar with the intent to kidnap the bar owner, Humberto Velasquez Sanchez, over an alleged debt. A fourth suspect, identified as Hector Milla, waited outside as the driver of the getaway vehicle.

Allon, Barraza, and the third, unidentified suspect, were confronted inside the bar by Manuel Mendosa, who was armed with a firearm. A gun battle ensued and Allon and Mendosa were killed inside the bar as a result of the gun battle.

Barraza sustained fatal wounds, but escaped and was later found in the getaway vehicle, which was located near the bar the next morning. Sanchez sustained multiple gunshot wounds and was taken to a local hospital, where he currently remains in stable condition.

We are currently seeking two outstanding suspects: Hector Milla, driver of the getaway vehicle, and the third suspect who remains unidentified. Milla, also known as Arnaldo Perez Santana and by the nickname of "Mono," has a no-bail warrant for his arrest in this case, charging violation of section 187 of the California Penal Code -- Homicide.

It is unknown if Milla is armed with a firearm, and it is believed he is possibly headed to Southern California or Mexico.

On March 2nd, 2011, detectives responded to Trace Elementary School and took Suspect Zingale into custody without incident. Suspect Reyes remains at large. The investigation is on-going.

The reporting party (later identified as the victim of extortion) stated that her friend (later identified as Suspect Delgado) had called her on January 27th and told her that his cousin had been kidnapped for ransom in San Diego. Suspect Delgado asked the victim for money to help free his cousin. On February 1st, the victim gave Suspect Delgado \$6,500 to pay the ransom. Suspect Delgado later told the victim that the captors had taken the money but killed his cousin anyway.

The victim contacted the San Diego Police Department. The San Diego Police referred the victim to the San Jose Police Department. At approximately 2:55 P.M., the victim called the San Jose Police. San Jose Police Robbery and METRO units immediately began working the case.

During the investigation, Suspect Delgado called the victim several more times to ask if the police had been called and to provide possible locations to deliver the ransom money. At approximately 8:30 P.M., METRO and Robbery units located both suspects in the 200 block of Santa Clara Street. The investigation revealed that both suspects had conspired to extort the victim by lying to her about the kidnappings so that she would feel compelled to help. Both suspects were booked into jail for felony extortion and conspiracy.

At 12:15 p.m., officers were dispatched to a reported minor-injury traffic collision involving a Green 2008 Ford Fusion 4-door sedan and a red 2001 Saturn 4-door sedan.

Edward Robledo, 20, of San Jose, was identified as the driver of the Ford Fusion. Robledo sustained a minor head injury and was treated at the scene by paramedics and released.

**San Jose:** On 1/24/11, 6:36 p.m., the San Jose police received a report of a green laser beam striking a private aircraft over the area of Story Road and McLaughlin Avenue. The Santa Clara County Sheriff's helicopter was in service and responded to the area, at which time it too was struck with a green laser beam. The sheriff's helicopter spotter suffered temporary flash blindness, but did not require medical attention

The sheriff's helicopter pilot and spotter were able to isolate the location from which the beam originated and direct San Jose police ground units to the 1200 block of Pipe Dream Court, where Christopher Bengel, 24, of San Jose, was taken into custody. Bengel was booked into the Santa Clara County Jail on two counts of felonious interfering with an airborne aircraft. .

Technology has increased the brightness and effectiveness of handheld laser pointers and at the same time reducing the cost. These lasers have the ability to cause temporary and/or permanent vision damage. A handheld laser pointer was found in Bengel's home at the time of his arrest.

Commercial, private, law enforcement, military and medical transport pilots have been getting struck with lasers while flying throughout the Santa Clara County Valley. The San Jose area is in the top five in the nation for frequency of laser strikes on aircraft. This number has been steady and, unfortunately, we have not seen a noticeable reduction.

The San Jose Police Department (SJPD), Airport Division, formed a Laser Strike Working Group (LSWG) with the assistance of the U. S. Federal Air Marshall. This group was formed in effort to reduce the frequencies of laser strikes on all aircraft, with the overall goal of completely eliminating them.

There are numerous law enforcement agencies, military and private sector pilots and organizations working together in the LSWG. There have been significant gains made throughout this last year since the Laser Strike Working Group was formed.

The help of the public is greatly needed in stopping this dangerous behavior. A pilot's vision can be incapacitated from a laser strike, increasing the likelihood of a fatal plane crash. It is not uncommon for individuals who shine their laser at aircraft to also shine it at other objects, such as houses and motor vehicles.

If you know of someone doing this in your neighborhood, or a household where this is occurring, notify your local law enforcement agency so they can take appropriate action and/or conduct outreach and education. Our primary goal is to increase the safety of the skies throughout the Bay Area as well as citizens on the ground.

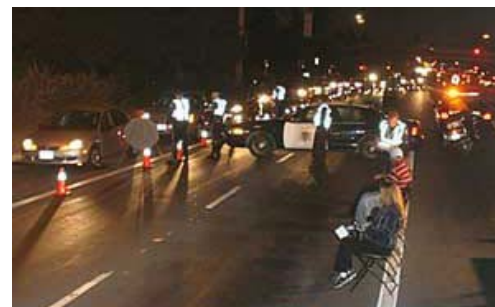

**San Jose:** On 1/21/11, at approximately 4:55 PM, San Jose police responded to reported shooting near the El Pollo Rico restaurant, 2687 Story Road, in San Jose (CA). Officers arrived and found the victim, identified as Hugo Gutierrez, suffering from multiple gunshot wounds.

The investigation reveals that Gutierrez was riding his bicycle on Story Road between Galahad Avenue and E. Capitol Expressway when he was approached by at least two other individuals. One suspect opened fire on the victim with a semi-automatic handgun, striking him several times. Gutierrez fell to the ground near the restaurant and was transported to a local hospital, where he was pronounced dead.

One suspect, an Hispanic male juvenile whose identity is being withheld due to his age, was taken into custody by responding units. The investigators have determined this to be a gang-related homicide.

This marks San Jose's seventh homicide of the year (five incidents resulting in seven homicides), although two additional homicides are being reported in 2011 by our department resulting from two previous and separate incidents where the victims died in January 2011.

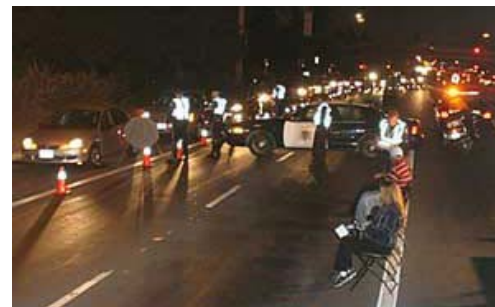

It is believed that during the course of the conversation, the suspect accused the victim of being responsible for the murder of Jeanine Harms (a homicide case in the city of Los Gatos in 2001). The investigation has revealed that the suspect was Jeanine Harm's brother.

The investigation revealed Tran had befriended and obtained a ride from the victim the previous day, at approximately 6:00 a.m., in the area of Senter and Lewis roads, in San Jose.

Once inside the victim's vehicle, Tran produced a handgun and told the victim he would kill him if he did not follow his instructions. Tran was apparently upset after learning his girlfriend was also involved in a relationship with the victim.

Tran forced the victim to drive for several hours throughout San Jose, down to Los Angeles County, and back to San Jose.

While traveling on U.S. route 101, Tran discharged his handgun inside the victim's car and told the victim he was serious about killing him if he did not follow his instructions. Tran demanded several thousand dollars as a ransom. Tran told the victim he would allow him to live in exchange for the ransom.

Tran forced the victim to stop at various locations throughout their travels and directed the victim to call his family for the ransom.

Once Tran and the victim returned to San Jose, they drove to Tran's car. Tran forced the victim into his car; Tran drove while holding the victim captive in the front passenger seat at gunpoint.

Shortly before 9:30 a.m., Tran drove to the Bank of America branch, 1510 The Alameda, in San Jose, where he directed the victim to withdraw the ransom amount. Tran accompanied the victim into the bank, where the victim proceeded to withdraw the ransom amount.

The San Jose Police Department learned that Tran and the victim were inside the bank and dispatched patrol officers and robbery detectives to that location.

At 9:27 a.m., the officers and detectives located and arrested Tran in the parking lot of the bank; the victim was located inside the bank.

Tran was booked into the Santa Clara County Jail on the following felonious charges, where he currently remains without bail.

**UPDATE: Jan. 12, 2011 / 3:30 p.m. / Officer Jose Garcia #3532**

On Wednesday, Jan. 12, 2011, at approximately 11:56 a.m., San Jose police officers arrested Tewelde Hailesslassie inside his residence in the 700 block of Piercy Road. Hailesslassie had been sought on an attempted murder arrest warrant.

Patrol officers and investigators had been actively investigating this case from the onset and had reason to believe Hailesslassie had been visiting his house in the last few days.

While checking the house today, patrol officers located Hailesslassie's Silver/Gray 2009 Toyota Sienna sports van parked approximately 1/4 of a mile from the house. Believing Hailesslassie was inside the house, officers obtained consent from the victim to enter and search the residence.

Officers entered the house and discovered Hailesslassie hiding inside a closet, under a large pile of clothing. While taking Hailesslassie into custody, officers found Hailesslassie with a self-inflicted laceration to the throat, in what appeared to be an attempt to inflict a fatal wound.

Officers immediately administered first aid to Hailesslassie and summoned paramedics. Hailesslassie was taken to Santa Clara County Valley Medical Center, where he was admitted for treatment and currently is listed in stable condition. Hailesslassie remained conscious and alert the entire time he was in contact with the officers and while being taken to the hospital.

Hailesslassie was not armed and did not resist arrest while being apprehended. Officers located the knife he used to self inflict the throat wound in a separate location in the house from where he was hiding.

**San Jose:** The San Jose Police Department is investigating a triple homicide that occurred on Saturday, Jan. 8, 2010, at the Mexicali Club, 939 Oakland Road, in San Jose. Police received 9-1-1 calls at 8:27 p.m. of shots fired inside the bar. Three males reportedly entered the club while armed with firearms and a gun battle ensued.

The investigation reveals that three suspects, two of whom have been identified as Antonio Allon and Manuel Barraza, entered the bar with the intent to kidnap the bar owner, Humberto Velasquez Sanchez, over an alleged debt. A fourth suspect, identified as Hector Milla, waited outside as the driver of the getaway vehicle.

Allon, Barraza, and the third, unidentified suspect, were confronted inside the bar by Manuel Mendosa, who was armed with a firearm. A gun battle ensued and Allon and Mendosa were killed inside the bar as a result of the gun battle.

Barraza sustained fatal wounds, but escaped and was later found in the getaway vehicle, which was located near the bar the next morning. Sanchez sustained multiple gunshot wounds and was taken to a local hospital, where he currently remains in stable condition.

We are currently seeking two outstanding suspects: Hector Milla, driver of the getaway vehicle, and the third suspect who remains unidentified. Milla, also known as Arnaldo Perez Santana and by the nickname of "Mono," has a no-bail warrant for his arrest in this case, charging violation of section 187 of the California Penal Code -- Homicide.

It is unknown if Milla is armed with a firearm, and it is believed he is possibly headed to Southern California or Mexico.

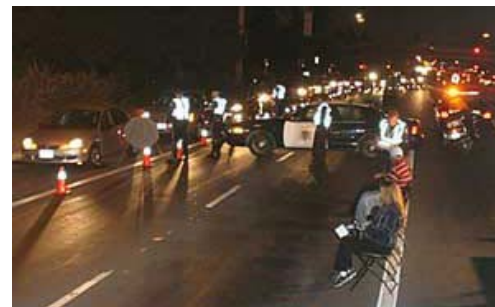

The victim was approached by Suspect #1 while inside the Target store and offered to sell her a bar of gold for \$12,000.00. Suspect #1 told the victim his son had sustained serious injury after recently being struck by an automobile. Suspect #1 explained to the victim that the vehicle had dropped a bag containing two gold bars while fleeing the scene of the collision.

Suspect #1 showed the victim what appeared to be a bar of gold, and said his son was currently hospitalized and he wished to sell the bar of gold in order to obtain money to pay for his son's medical costs.

Suspect #2 approached Suspect #1 and the victim and offered to purchase one of the gold bars. Suspect #2 gave Suspect #1 his wallet and/or ID to show good faith while offering to take the gold bar to a nearby jeweler for appraisal.

Suspect #2 returned after a few moments, saying the gold bar had been appraised at \$25,000.00. Both suspects convinced the victim she should purchase the gold bar for \$12,000.00 in order to make a quick profit.

Both suspects accompanied the victim to two separate banks, where she withdrew \$12,000.00 cash to purchase the gold bar. Suspect #1 accepted the money from the victim in exchange for the gold bar. The victim later determined the apparent gold bar to be fake.

Preliminary investigation reveals this type of fraudulent activity has occurred in various cities throughout California and other parts of the nation.

Similar scams reported to police include individuals claiming to be foreign nationals approaching victims at or near banks or retail stores, requesting the victims give them large sums of money in order to assist the suspects in cashing winning lottery tickets or inheritances. The suspects then take the money and leave the scene without returning.

Suspects often prey on victims who are elderly or Spanish-speaking, appealing to sympathy or a desire to make a quick profit.

On July 7, 2010, the victims reported having been defrauded by a money wire transfer business in San Jose which operated under the name of The3mien.com.

The business would accept the victims' monies but would keep the funds rather than transferring them to victims' intended recipients in Vietnam. The business is also being investigated for a second form of consumer fraud, in that the business sold pre-paid calling cards to many customers, only to find the cards had been deactivated soon after their purchase or, simply, had never been activated at all.

San Jose Police investigators have determined these incidents of consumer fraud occurred between June and July, 2010, and found that the business had since closed its doors for business.

The owner of The3mien.com operated a second store in Westminster, California, under the same name, which is also currently under investigation by the Westminster Police Department for consumer fraud. That store had also since closed its doors for business.

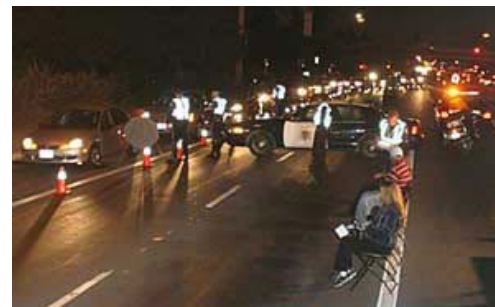
