Follow up investigation by detectives lead to the identification of the driver of the vehicle. On Sunday, June 18, 2017, the driver voluntarily walked into the San Jose Police Department and agreed to be interviewed regarding the incident. Detectives interviewed the driver and released him, pending a review by the Santa Clara County District Attorney's Office.

San Jose, Calif. - On Saturday, June 17, 2017, at approximately 12:08 AM, two San Jose Police officers were assigned in a two person marked police vehicle. They were patrolling in the 1700 block of Oakland Road when they approached a red Mazda Miata that was parked in a parking lot. The officers were looking for this vehicle because it had evaded them earlier when they attempted to stop it for reckless driving.

As the officers approached the vehicle, the lone driver placed the vehicle in reverse, then accelerated towards one of the officers. The victim officer fired the service weapon at the suspect in defense of the victim officer's life. The suspect driver fled in the vehicle and was able to escape. The officers were not injured.

The suspect is described as a Hispanic male, early 20's. At this time, it does not appear the suspect was injured in the confrontation and area hospitals were checked for walk in shooting victims - none were found.

The suspect vehicle is described as a red Mazda Miata with a black convertible top and paper license plates.

The officer was placed on routine paid administrative leave. The San Jose Police Department's Homicide Unit is conducting the criminal investigation. The case is being monitored by the San Jose Police Department's Internal Affairs Unit, the City Attorney's Office, and the Office of the Independent Police Auditor.

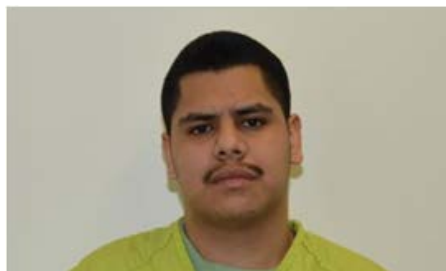

San Jose, CA — In response to community concerns, the San Jose Police Department's METRO Unit conducted a fireworks investigation from April thru June, 2017, to address the issue of using and possessing fireworks within the City of San Jose.

Officers used social media and other investigative strategies and confiscated over 2,700 lbs. of fireworks. They also collected 3", 4", and 5" mortars which are considered explosives.

The California State Fire Marshall's Office and the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) participated in the investigation.

Two individuals were identified for distribution of illegal fireworks. There is an active warrant for one suspect associated with this investigation. The suspect's name will not be released until the suspect is apprehended and the investigation has concluded. This is an on-going investigation.

San Jose PD will continue to collaborate with other agencies and City of San Jose departments to suppress the use of fireworks.

Chief Eddie Garcia said, "We recognize and have heard the community's concerns over the dangers and nuisance that illegal fireworks cause, especially as we get closer to the 4th of July. With these concerns in mind, our Special Operations did what they do best and responded with an extraordinary seizure."

San Jose Fire Chief Curtis Jacobson said, "As responders to many injuries and fires that are caused by fireworks, SJFD deeply appreciates the investigative and enforcement work put forth by our San José Police. Continued vigilance by officers as well as reporting of fireworks use from our residents will help to protect lives and property, and change the way people view fireworks."

Operation Broken Heart IV – Silicon Valley ICAC Task Force

San Jose, CA — The San Jose Police Department proudly serves as the lead agency of the Silicon Valley Internet Crimes Against Children Task Force (SVICAC). SVICAC participated in “Operation Broken Heart IV”, which joined 60 other ICAC Task Forces nationwide in identifying and arresting suspected child sexual predators during April and May 2017.

During “Operation Broken Heart IV”, the SVICAC Task Force arrested 30 suspected child predators and participated in 28 community presentations on Internet/social media safety. Dozens of bay area law enforcement agencies who are members of the SVICAC Task Force participated.

Nationally, the operation resulted in 1,012 arrests and the task forces conducted 1,245 presentations.

The national crackdown targeted offenders who: (1) possess, manufacture, and distribute child pornography; (2) engage in online enticement of children for sexual purposes; (3) engage in the commercial sexual exploitation of children (commonly referred to as child prostitution), and (4) engage in child sex tourism (traveling abroad for the purposes of sexually abusing foreign children).

The Operation included more than 4,500 federal, state, and local law enforcement agencies across the United States.

Mission:

The Internet Crimes Against Children Task Force Program (ICAC program) helps state and local law enforcement agencies develop an effective response to technology-facilitated child sexual exploitation and Internet crimes against children. This help encompasses forensic and investigative components, training and technical assistance, victim services, and community education.

Background:

The ICAC program was developed in response to the increasing number of children and teenagers using the Internet and other technology, the proliferation of child sexual abuse images available electronically, and the heightened online activity by predators seeking unsupervised contact with potential underage victims. Because ICAC members understand that arrests alone cannot resolve the problem of technology-facilitated child sexual exploitation, the ICAC program is also dedicated to training law enforcement officers and prosecutors, as well as educating parents and youth about the potential dangers of online activity.

Since 1998, ICAC Task Forces have reviewed more than 580,000 complaints of alleged child sexual victimization resulting in the arrest of more than 60,000 individuals.

San Jose Police Chief Eddie Garcia will be joined by Mayor Sam Liccardo and members of the San Jose City Council to celebrate the launch of San Jose Police Academy Class 30 which boasts 54 new recruits. This class size is tied with an academy in 2013 as the largest since 2007.

On Friday, June 16, 2017, SJPD Academy Class 30 will begin with 54 new recruits. The 6-month long academy is the first step in preparing prospective officers, and includes a mix of classes and physical training. Following the academy, recruits enter a 16-week Field Training Program, where they work alongside a veteran officer. Upon completing the field training program, officers are considered "street ready" and begin their regular assignment.

Chief Eddie Garcia said, "This is a momentous occasion. The starting of this academy is both symbolic and tangible. It is symbolic because it truly represents this Departments re-birth. It is tangible because we now have approximately 110 officers or future officers in the training process. These additions and the trajectory of our recruiting will enable us to provide better service delivery to our residents. What cannot be lost is what this also means to our current rank and file, officers that have sacrificed so much for this community in years of crisis. To them I would say, 'Thank you for answering the call to serve in dark times, but help is on the way.' "

San Jose POA President Paul Kelly said, "The size of this academy validates our collective efforts to restore our police department to try and keep our neighborhoods safe. It has been a long slog and there is still much work to be done, but after years of strife, our department is headed in the right direction."

Mayor Sam Liccardo said, "The start of today's 54-person academy highlights the great progress we're making on improving public safety in San Jose and providing our residents with the level of service they deserve. Our collective efforts to restore staffing, morale and trust has enabled a great department to thrive again. I'd like to thank all of these new recruits for answering the call to serve our community and to keep our neighborhoods safe."

With the start of this new academy, the San Jose Police Department now has over 100 new officers in the training process:

- Academy Class 28: 27 recruits are currently in the 16-week field training program
- Academy Class 29: 26 recruits are mid-way through their academy training (graduation in August)
- Academy Class 30: 54 recruits begin their academy training this week (graduation in December)

In 2017, the Department hired 4 lateral police officers (one of the officers was a rehire). Current staffing with the new recruits is 983 sworn personnel.

San Jose, CA — The San Jose Police Department's Robbery Unit has been investigating a series of at least eleven (11) robberies which occurred between February 2017 through April 2017. The robberies targeted liquor stores and pharmacies throughout San Jose where the suspects used knives, pepper spray, and physically assaulted employees.

On several robberies, suspect Ezekiel Zamora brought a juvenile female suspect to assist him with the robberies.

On 04-21-17, SJPD Covert Response Unit officers arrested Zamora and the juvenile suspect in the area of Alvin Ave. and Flanigan Dr. in San Jose. During the apprehension, Zamora attempted to evade officers by driving a stolen vehicle through a fence while a different juvenile was inside the vehicle. Zamora has since been charged with multiple counts of robbery and child endangerment.

The case is still on-going and actively being investigated. We are asking for the public's assistance in identifying additional victims who may have not reported their robbery to the police. San Jose, Calif. - On Sunday, May 28, at approximately 12:35 AM, San Jose police officers were dispatched on report of a disturbance involving a tenant in the apartment complex located on the 100 block of E. St. John St. Security at the complex had called the San Jose Police for assistance as the subjects were not compliant. Several officers arrived on scene and attempted to make contact with the suspect who was inside an apartment and refusing to open the door. Officers observed flames and smoke coming from underneath the front door. Fearing for the lives of the occupants inside the apartment, they forced the door open.

Officers were immediately confronted by two suspects, one of whom was immediately taken into custody. The other suspect was armed with an axe. The suspect initially discarded the axe, but then did not comply with the officers commands. A Taser was deployed, however, it had no effect on the suspect. The suspect then rearmed himself with the axe and it was not until he began to threaten the officers with the axe and advance on the officers, that the officer was given no other choice than to discharge his firearm in the defense of his life and others in the immediate area. The suspect was struck at least once. The suspect was subsequently taken into custody and transported to a local hospital where he was pronounced deceased a short time later. The investigation revealed the fire was intentionally set by one of the suspects in an effort to deter the officers.

This suspect had numerous priors for violence, weapons, drugs and prior contacts for mental illness.

Chief Eddie Garcia said, "This is tragic for the suspect and for the suspects family, but what often gets lost in these cases is the impact on the officers, who seemingly have the deck stacked against them in these types of incidents. Officers who are tasked to perform the incredibly difficult task of diffusing a critical situation with someone already in a mental crisis, and when their attempts to diffuse the situation fail, I can assure you they are affected. This officer responded bravely, and almost certainly saved himself and his fellow officers from grave danger, in response to an almost impossible situation."

The officer was placed on routine paid administrative leave. The Santa Clara County District Attorney's Office and the San Jose Police Department's Homicide Unit are conducting a joint criminal investigation. The case is being monitored by the San Jose Police Department's Internal Affairs Unit, the City Attorney's Office, and the Office of the Independent Police Auditor.

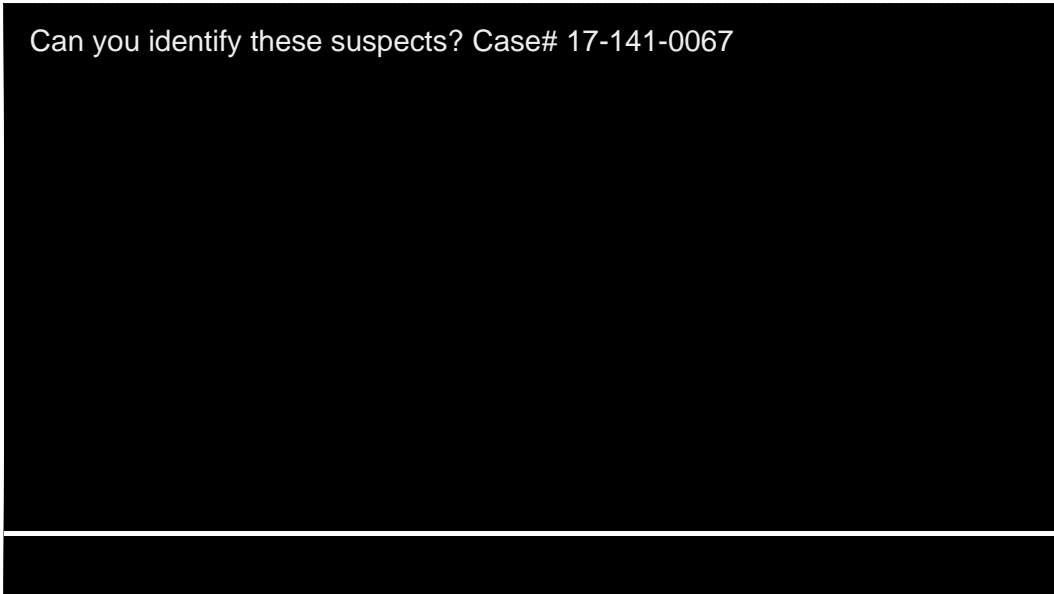

Last October, Americans turned in 366 tons (over 730,000 pounds) of prescription drugs at almost 5,200 sites operated by the DEA and more than 4,000 of its state and local law enforcement partners. Overall, in its 12 previous Take Back events, DEA and its partners have taken in over 7.1 million pounds—more than 3,500 tons—of pills.

This initiative addresses a vital public safety and public health issue. Medicines that languish in home cabinets are highly susceptible to diversion, misuse, and abuse. Rates of prescription drug abuse in the U.S. are alarmingly high, as are the number of accidental poisonings and overdoses due to these drugs. Studies show that a majority of abused prescription drugs are obtained from family and friends, including from the home medicine cabinet. In addition, Americans are now advised that their usual methods for disposing of unused medicines—flushing them down the toilet or throwing them in the trash—both pose potential safety and

health hazards.

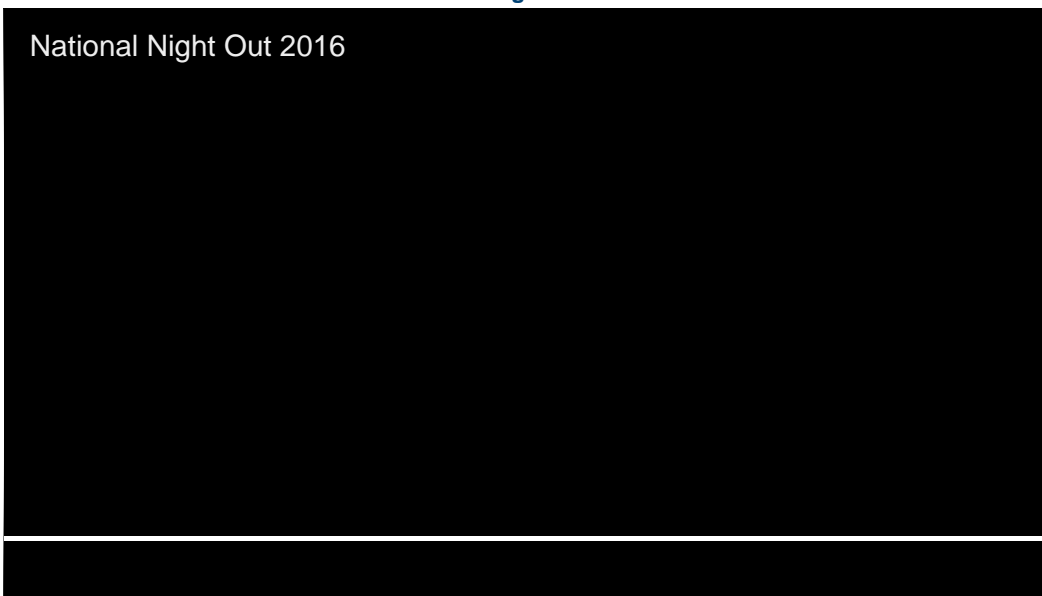

San Jose, CA - St. Patrick's Day has become one of the nation's favorite holidays to celebrate and party. Unfortunately, too many people are taking to the roads after drinking, making the holiday one of our most dangerous. According to the National Highway Traffic Safety Administration (NHTSA), 252 people lost their lives in drunk driving-related crashes during the St. Patrick's Day holiday period from 2011-2015. More than a fourth of them were killed in drunk driving crashes that occurred in the early morning, post-party hours (midnight to 5:59 a.m.).

That's why the San Jose Police Department and the California Office of Traffic Safety are teaming up to reach all drivers with an important life-saving message and warning: Don't Drive Impaired by Drugs or Alcohol.

"The San Jose Police Department, and the Traffic Enforcement Unit, will work hard to make sure St Patrick's Day is a festive day, not a tragic one," said Acting Lieutenant Steve Payne.

If you plan to celebrate this St. Patrick's Day, follow these tips to stay safe:

- ✳ Before celebrating St. Patrick's Day this year, decide whether you'll drink or you'll drive. You can't do both. *"Buzzed Driving is Drunk Driving"*
- ✳ If you're planning on driving, commit to staying sober. If you've been out drinking and then get behind the wheel, you run the risk of causing a crash or getting arrested for a DUI.
- ✳ Drugs such as many prescription medications, marijuana or illicit drugs can also lead to impairment and unsafe driving, leading to a DUI. When mixed with even a small amount of alcohol the affects can be compounded.
- ✳ If you have been drinking, call a taxi or sober friend or family member, use public transportation. You can download the Designated Driver VIP free mobile app, "DDVIP," for Android or iPhone. The DDVIP app helps find nearby bars and restaurants that feature free incentives for the designated sober driver, from free non-alcoholic drinks to free appetizers and more. The feature-packed app even has social media tie-ins and even a tab for the non-DD to call Uber, Lyft or Curb.
- ✳ Help those around you be responsible, too. Walking while impaired can also be deadly, as lack of attention could put you at risk of getting hit by a vehicle. If someone you know is impaired by alcohol or drugs, do not let them get behind the wheel and help them find a sober ride home.

San Jose Police Department Targets Impaired Drivers With Sobriety/Drivers License Checkpoint

San Jose, CA – The San Jose Police Department Traffic Enforcement Unit will be conducting a DUI/Drivers License Checkpoint on Friday, March 10, 2017, at an undisclosed location within the city limits, between the hours of 9:00 p.m. to 3:00 a.m.

The deterrent effect of High Visibility Enforcement using both DUI checkpoints and DUI Saturation Patrols has proven to lower the number of persons killed and injured in alcohol or drug impaired crashes. Research shows that crashes involving an impaired driver can be reduced by up to 20% when well-publicized proactive DUI operations are conducted routinely.

DUI Checkpoints like this one are placed in locations based on collision statistics and frequency of DUI arrests, affording the greatest opportunity for achieving drunk and drugged driving deterrence. Locations are chosen with safety considerations for the officers and the public.

In California, alcohol involved collisions led to 1,155 deaths and nearly 24,000 serious injuries in 2014 because someone failed to designate a sober driver.

Officers will be looking for signs of alcohol and/or drug impairment, with officers checking drivers for proper licensing, delaying motorists only momentarily. When possible, specially trained officers will be available to evaluate those suspected of drug-impaired driving, which now accounts for a growing number of impaired driving crashes.

Studies of California drivers have shown that 30% of drivers in fatal crashes had one or more drugs in their systems. A study of active drivers showed more tested positive for drugs that may impair driving (14%) than did for alcohol (7.3%). Of the drugs, marijuana was most prevalent, at 7.4%, slightly more than alcohol. Everyone should be mindful that if you're taking medication – whether prescription or over-the-counter – drinking even small amounts of alcohol can greatly intensify the impairment affects.

Drivers are encouraged to download the Designated Driver VIP, or "DDVIP," free mobile app for Android or iPhone. The DDVIP app helps find nearby bars and restaurants that feature free incentives for the designated sober driver, from free non-alcoholic drinks to free appetizers and more. The feature-packed app even has social media tie-ins and even a tab for the non-DD to call Uber, Lyft or Curb.

Drivers caught driving impaired can expect the impact of a DUI arrest to include jail time, fines, fees, DUI classes, license suspensions and other expenses that can exceed \$10,000 not to mention the embarrassment when friends and family find out.

Funding for this checkpoint is provided to the San Jose Police Department by a grant from the California Office of Traffic Safety, through the National Highway Traffic Safety Administration, reminding everyone to "Report Drunk Driver – Call 9-1-1."

SJPD Arrest "Geisha Dolls" Crew Responsible for a Series of Armed Robberies

San Jose: The San Jose Police Department's Robbery Unit has identified and arrested three suspects in a connection with a series of robberies of gas stations, liquor stores, and markets in the City of San Jose and Milpitas. The crimes occurred between October 23, 2016 to January 25, 2017. Between one and three suspects entered the stores during this robbery string, while armed with either a handgun or a large knife. The suspects wore masks to cover their faces. This crew was dubbed "Geisha Dolls" based on their disguises during the earlier part of their string. The suspects would threaten the clerks, while demanding money. Some of the victims were pistol-whipped during the commission of the robberies. These three suspects are believed to have committed at least 12 armed robberies since October 23, 2016.

The coordinated investigation by Robbery Detectives included interviewing victims and witnesses, gathering physical evidence, and conducting surveillance. Sergeant Ron Starkey of the Robbery Unit stated that the success of the investigation, leading to the arrests of three suspects, was a direct result of the teamwork within the Robbery Unit.

During the investigation, Robbery Detectives had identified a person of interest. Further investigation led to the identification of two additional suspects, a 16 year old and 17 year old.

On 1-25-2017, an armed robbery occurred at the Arco AM/PM located at 2104 N Capitol Ave. Patrol Officers immediately followed up on leads and arrested a juvenile suspect at his residence. Patrol officers conducted a search of the residence and located evidence of the Arco AM/PM robbery.

Robbery Detectives were notified of the arrest by patrol officers and recognized the individual from their investigation of the Geisha Dolls robbery crew. Robbery Unit Detectives mobilized and coordinated to conduct additional searches at the 17 year old's residence. Based on the additional follow up on 1-25-2017, Robbery Detectives discovered evidence linking the suspect arrested by patrol, and of the entire robbery crew, to 12 robberies. The 17 year old Juvenile was booked into custody at Santa Clara County Juvenile Hall.


On February 14, 2017 members of the Metro Unit located and arrested Suspect #1 (a 17 year old at the time of the crime) and a 16 year old Juvenile in San Jose.

The case is still on-going and actively being investigated. We are asking for the public's assistance in identifying additional victims of these robberies who may have not reported their robbery to police.

The suspects were described as follow:

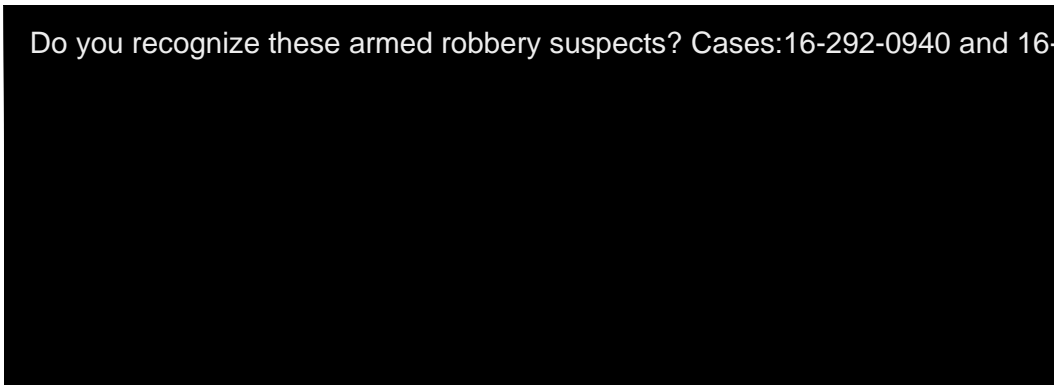

Analysis of San Jose Police “Stop” Data Shows Fewer Racial Disparities than Expected

San Jose, Calif. - A comprehensive analysis of San Jose Police Department “limited detention” (or stop) data has revealed that in general there were fewer statistically valid differences in the experience of pedestrians and drivers of different races when they are stopped by San Jose officers than might have been expected in a community as diverse as San Jose.

The report also found there were some racial disparities in the patterns and practices for how SJPD handles vehicle and pedestrian stops.

The study, conducted by the Center for Law and Human Behavior at the University of Texas at El Paso, was based on data collected by SJPD for 30 months from September 2013 through March 2016. SJPD contracted with UTEP in February 2016 to conduct a statistical analysis of limited detention data and provide recommendations to address and reduce disparities in limited detention actions.

“The San Jose Police Department is a professional police department with no apparent cultural issues,” said Dr. Michael Smith, the lead researcher from UTEP.

San Jose Police Chief Eddie Garcia said, “The good news is SJPD is not a department in crisis.”

The final report represents an extensive examination of the correlation between individuals' race/ethnicity and traffic/pedestrian stop outcomes. The report also provides a series of recommendations for the Police Department, including ways to improve data collected during stops, as well as recommended policies, practices, and training to reduce any potential police bias.

“I am proud of the professionalism of the men and woman of this department and the tremendous job they do daily, however I also recognize that we are not perfect. We'll never stop striving for fairness in the way we serve and protect our residents. Regardless of these findings, I recognize that there is a level of distrust of police in parts of our community, and our entire department must always keep working to increase trust and improve perceptions of police legitimacy,” said Police Chief Eddie Garcia.

“We've already made a deep commitment to the high standards for 21st Century Policing and to fostering a departmental culture where crime reduction and community trust go hand in hand. This study is one of many initiatives our police department has undertaken to earn that trust and achieve better community safety. The first step in any effort to improve is self-assessment, and this report provides a critical benchmark of existing stop practices that will help us make more progress.”

The analysis is the outcome from the San Jose Independent Police Auditor's recommendation in 2012 that the police department adopt a policy requiring officers to document when they make a stop and require an individual to sit on the curb, handcuff them, or place them in the back of a police car for the purposes of a limited detention.

SJPD followed up and implemented the new policy in September 2013 to document limited detentions that include curb sitting, temporarily handcuffing, or temporarily placing persons in a police vehicle during self-initiated pedestrian and vehicle stops.

Chief Garcia and the UTEP research team will present the study findings and recommendations to the San Jose City Council on Tuesday, February 28, 2017.

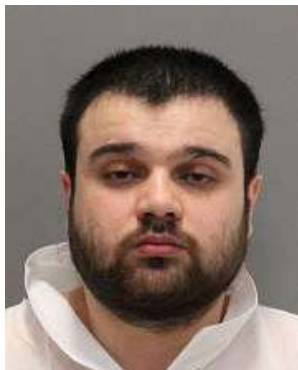
