San Jose, CA — On Sunday, October 29, 2017, at approximately 10:00 PM, San Jose police officers along with the California Highway Patrol, Santa Clara County Sheriff's Office, and Morgan Hill Police Department conducted a racer enforcement operation at various locations throughout the City of San Jose.

A San Jose police officer was struck by a vehicle during a traffic enforcement stop for reckless driving on Hostetter Road near Highway 680. The officer was treated at a local hospital for non-life threatening injuries. The solo occupant driver fled the scene and evaded pursuing officers who obtained a partial license plate number. Follow-up investigation by the Assaults Unit led to the suspect's identity.

On Friday, November 3, 2017, at approximately 3:30 PM, suspect Huerta-Cabrera was taken into custody at his residence by the San Jose Police Department's Violent Crimes Enforcement Team and METRO Unit. Suspect Huerta-Cabrera was subsequently

booked into the Santa Clara County Jail for Assault with a Deadly Weapon and Felony Evading.

San Jose CA — The San Jose Police Department's Robbery Unit has been investigating a series of at least seven Armed and Strong-Arm Robberies that occurred between July 2017 and September 2017 in San Jose. The robberies targeted elderly East Indian and Asian females where the suspect would approach the victims and grab their gold chain from around their neck. In one of the robberies the suspect used a gun.

On October 26, 2017, San Jose Police Department's Covert Response Unit officers arrested Carter in San Jose and booked him into Santa Clara County Jail for Robbery (3 counts), Elderly Abuse (2 counts), Assault with a Deadly Weapon, and Vandalism



SAN JOSE POLICE DEPARTMENT RECEIVES GRANT FOR SPECIAL TRAFFIC ENFORCEMENT AND CRASH PREVENTION

San Jose, CA — San Jose Police Department has been awarded a \$257,000 grant from the California Office of Traffic Safety (OTS) for a year-long program of special enforcements and public awareness efforts to prevent traffic related deaths and injuries. San Jose Police Department will use the funding as part of the city's ongoing commitment to keep our roadways safe and improve the quality of life through both enforcement and education.

"Traffic Safety is our number one priority and our goal is to make it the number one priority of every driver in San Jose. This OTS Grant will help us put more Officers on the street and help us achieve this goal," said Sergeant Steven Payne.

After falling to a ten year low in 2010, the number of persons killed on roadways has climbed nearly 17 percent across the state, with 3,429 fatalities in 2015. Particularly alarming is the rise in pedestrian and bicycle fatalities that now comprise nearly 25 percent of all traffic deaths, along with the growing dangers of distracting technologies and the emergence of drug-impaired driving. This grant funding will provide opportunities to combat these and other devastating problems such as speeding and crashes at intersections.

"Unsafe behaviors account for 94 percent of traffic crashes," said OTS Director Rhonda Craft. "This grant emphasizes the two most effective ways to change behaviors – education and enforcement. San Jose Police Department, with assistance from the Office of Traffic Safety, will use these tools to help keep San Jose streets safe."

Activities that the grant will fund include:

- ✿ Educational presentations
- ✿ DUI checkpoints
- ✿ DUI saturation patrols
- ✿ Bicycle and pedestrian safety enforcement
- ✿ Motorcycle safety enforcement
- ✿ Distracted driving enforcement
- ✿ Seat belt and child safety seat enforcement
- ✿ Speed, red light, and stop sign enforcement

While alcohol remains the worst offender for DUI crashes, the San Jose Police Department supports the new effort from OTS that aims to drive awareness that “***DUI Doesn’t Just Mean Booze.***” Prescription medications and marijuana can also be impairing by themselves, or in combination with alcohol, and can result in a DUI arrest.

Funding for this program is from the California Office of Traffic Safety through the National Highway Traffic Safety Administration.

A collaborative investigation between the San Jose Police Department, Milpitas Police Department, South San Francisco Police Department and Fremont Police Department determined that there were four cases between September 27 and September 28, 2017, involving the same suspects.

On September 27, 2017, at approximately 10:26 AM, Milpitas police officers responded to a suspicious circumstance call in the 500 block of Murphy Ranch Road in Milpitas. Arriving officers located a female victim who reported being robbed and sexually

assaulted.

On September 28, 2017, at approximately 3:00 PM, Fremont police officers responded to a home invasion robbery in the city of Fremont. Arriving officers located three female victims who reported being robbed at gunpoint. One of the victims also reported being sexually assaulted.

On September 29, 2017, South San Francisco police officers responded to a robbery call in 100 block of McLellan Drive in South San Francisco. Arriving officers located a female victim who reported being robbed and sexually assaulted at gunpoint two days prior (9-27-17, at 1:50 PM).

All four locations were determined to be operating brothels.

Follow up investigation by the involved agencies lead to the identity of three suspects in these cases.

On Wednesday, October 18, 2017, the Los Angeles County Sheriff's Department was instrumental in providing substantial resources including investigative and tactical assistance, resulting in the successful apprehension of Suspects 1, 2, and 3, at their respective residences.

The suspects were booked into the Los Angeles County Jail for Murder - 187(A) PC, Assault with a deadly weapon - 245(A)(2) PC, Conspiracy - 182(A)(1) PC, Robbery - 211/213(A)(1)(A) PC, Kidnapping - 209(B)(1) PC, and Sexual Assault -261(A)(2) PC.

Detectives are asking for the public's assistance in identifying and locating Suspect #4 and Suspect #5 shown in the above photos and embedded video.

Suspect #4 is described as a Chinese male, 25-30 years-old, 5' 10" to 5' 11", 160-170 lbs., shaved head, last seen wearing a school varsity type jacket - blue in color with tan sleeves.



San Jose, CA – The San Jose Police Department’s Division of Medical Marijuana Control will be holding a community meeting to discuss whether or not to allow registered medical cannabis collectives to add non-medical (“recreational / adult-use”) cannabis transactions.

With voter approval of Proposition 64, the Adult Use of Marijuana Act, in November 2016, non-medical cannabis became legal for those over age 21 in California. Non-medical cannabis includes “adult use” or “recreational” cannabis.

The State of California will begin issuing licenses for medical and non-medical cannabis operators in January 2018. To obtain a state license, an operator must have local authorization (or a “Registration” in San José).

San José has 16 registered medical marijuana collectives. Registration is not open to new applicants, and only the City Council can re-open the registration process.

At the Oct. 30 meeting, the following questions will be addressed:

1. Shall the City allow existing registered medical marijuana collectives to provide non-medical marijuana?
2. Shall existing registered medical marijuana collectives be allowed to deliver non-medical cannabis to people over the age of 21?

An employee attempted to stop the suspects but was knocked to the ground, sustaining minor injuries. The suspects fled in a dark colored Jeep with paper plates.

At approximately 10:52 PM, four male suspects attempted to gain entry into a residence in the 2500 block of Cottle Avenue. The homeowner armed himself with a gun and confronted the armed suspects in the front yard. The homeowner was shot at least once and was transported to a local hospital with non-life threatening injuries. The suspects fled in a dark colored SUV.

At approximately 11:05 PM, San Jose police officers received a call of multiple suspects rummaging through a vehicle in the area of Mary Lee Way at Woodmont Drive. Arriving officers located an unoccupied, stolen black Jeep, with multiple bullet holes in it. This location is a few blocks from the above shooting incident.

On Thursday, October 12, 2017, at approximately 3:00 AM, an occupied residential burglary occurred in the 1200 block of Norval Way. A Green Kia was stolen from the residence.

At approximately 4:30 AM, an occupied residential burglary occurred in the 500 block of Hyde Park Drive. The suspects stole a white Mercedes and black Range Rover.

At approximately 4:43 AM, suspect Michael Velavalencia was arrested by San Jose patrol officers for possession of a stolen vehicle. Follow-up investigation revealed Velavalencia was also involved in the above listed crimes along with the listed juveniles. Velavalencia was subsequently booked into the Santa Clara County Jail for 459 PC-Burglary (2 counts), 496 PC-Possession of stolen property, 148 PC-Resisting arrest, 10851 CVC-Possession of a stolen vehicle, and 2800 CVC-Evading a peace officer.

At approximately 9:30 AM, a carjacking occurred at the Tamien Light Rail Station, located at 499 West Alma Avenue in San Jose (Santa Clara County Sheriff's jurisdiction). Three male suspects arrived in the stolen white Mercedes and took the victim's vehicle by force.

At approximately 3:40 PM, suspects #3, #4 and #5 were arrested in San Jose by officers from the Santa Clara County Regional Auto Theft Task Force in the white Mercedes. Suspect #3 was arrested for 459 PC-Burglary (2 counts), 215 PC-Carjacking, and 10851 CVC-Possession of a stolen vehicle. Suspect #4 was arrested for 215 PC-Carjacking and 10851 CVC-Possession of a stolen vehicle. Suspect #5 was arrested for 10851 CVC-Possession of a stolen vehicle.

WHAT YOUR TEEN DRIVER NEEDS TO KNOW TO SURVIVE

San Jose, CA Car crashes are the leading cause of death for teenagers, ahead of all other types of injury, disease, or violence. To shed light on this epidemic and reduce the number of lives lost, the San Jose Police Department wants to draw public attention to National Teen Driver Safety Week, October 15-21.

The National Highway Traffic Safety Administration reports that nationwide in 2015, 1,972 drivers, age 15-18, were involved in fatal collisions. In 2015, in California, 283 teens were behind the wheel at the time of fatal collisions, and 63 percent of those young drivers were at fault.

Teen Driver Safety Week will help parents focus attention on setting rules for their teen driver before allowing them to get behind the wheel. Parents and guardians must set firm driving rules to impact their teens driving behavior. They can be the difference between life and death.

Inexperience is one of the leading causes of teen collisions. The most important thing a parent can do for a new teen driver is to stay involved in their driving life. Take frequent drives with your newly licensed teens to monitor their progress. Parents can reduce the dangerous and sometimes deadly behaviors, such as alcohol consumption, driving without seat belts, speeding, carrying extra passengers, and driving distracted.

Cell phone use continues to be a serious and often deadly distraction for all drivers, but its a significant problem among young, inexperienced drivers, said Rhonda Craft, Director of the California Office of Traffic Safety. If youre a parent, guardian, or mentor to a teen driver, lead by example and encourage them to put the phone down and focus on the road. No text message or social media post is more valuable than their lives or the lives of others around them.

As part of its commitment to educating the motoring public, there are programs for teen drivers and their families:

- *Start Smart* conducted by law enforcement personnel is a driver safety education class that targets new and future licensed drivers between the ages of 15-19 and their parents/guardians.

- ✿ The CHP has released a mobile application (app) for *Start Smart*, designed to assist young people through the process of obtaining their California driver license. The app includes a step-by-step guide covering everything from the Department of Motor Vehicles Driver Handbook and the final steps for obtaining a provisional license, to ultimately achieving an unrestricted California driver license.
- ✿ *Every 15 Minutes* focuses on high school juniors and seniors, challenging them to think about drinking, driving, personal safety, the responsibility of making mature decisions, and the impact their decisions have on family, friends, and many others.
- ✿ *Impact Teen Drivers*, a non-profit organization parented with CHP is dedicated to saving lives through evidence-based educational programs that support good decision-making strategies behind the wheel.
- ✿ *California Friday Night Live Partnership*, working with high schools and middle schools to educate teens about traffic safety and impaired driving awareness including Town Hall meetings, prom related campaigns, and parent awareness programming.
- ✿ *The Power to Youth and the Power of Parents*, MADDs multi-sensory high school assembly education program highlighting the dangers of teen impaired driver.
- ✿ *Students Against Destructive Decisions (SADD)*, educating and bring awareness to California communities of the human toll caused by alcohol related crashes to high school and middle school programs.

The San Jose PD is aware of the importance of role models in a youths development. Parents and other setting the example and education of new drivers and their families is regarded as a critical function to help keep everyone safe while driving.

Last April, Americans turned in 450 tons (900,000 pounds) of prescription drugs at almost 5,500 sites operated by the DEA and more than 4,200 of its state and local law enforcement partners. In addition, Americans are now advised that their usual methods for disposing of unused medicines—flushing them down the toilet or throwing them in the trash—both pose potential safety and health hazards.

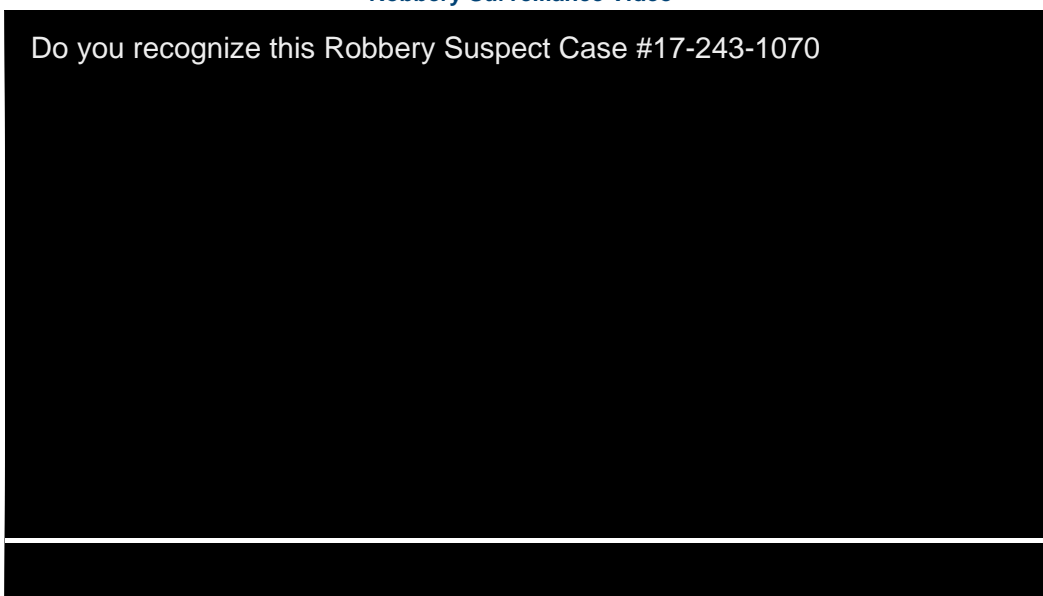

While officers were investigating the stabbing, they connected similarities of the suspect and suspect vehicle with another incident that had occurred on Hellyer Avenue and Palisade Drive approximately 5 minutes earlier. In that incident, a suspect attempted to stab another adult male victim, but the victim was able to escape unharmed and called police.

A broadcast was issued for the suspect vehicle. A Santa Clara County Sheriff's deputy spotted the suspect in the vehicle on Bentoak Lane in San Jose. The suspect was detained until detectives arrived and arrested him without incident.

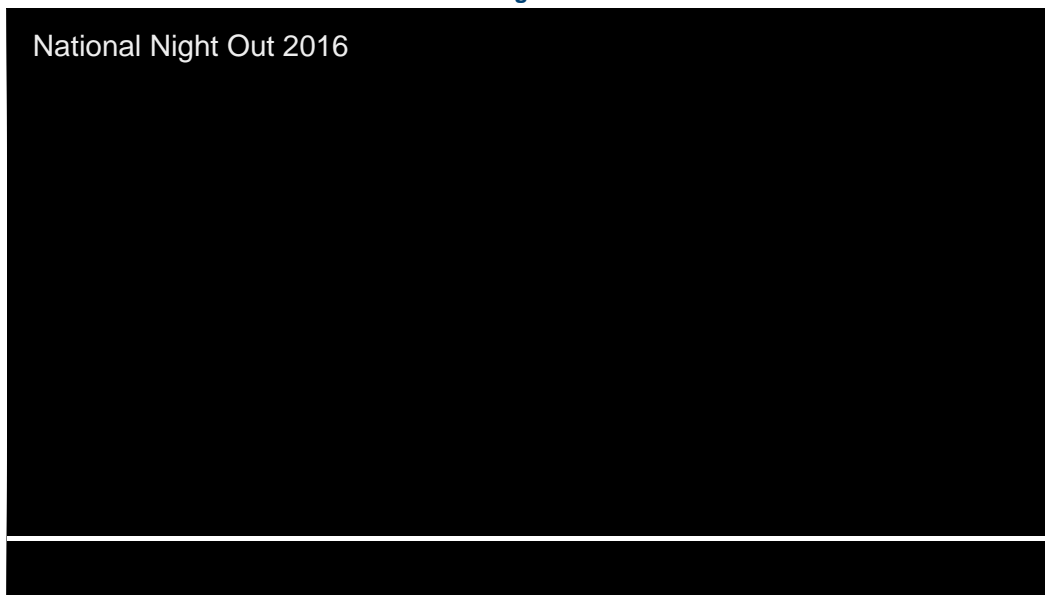

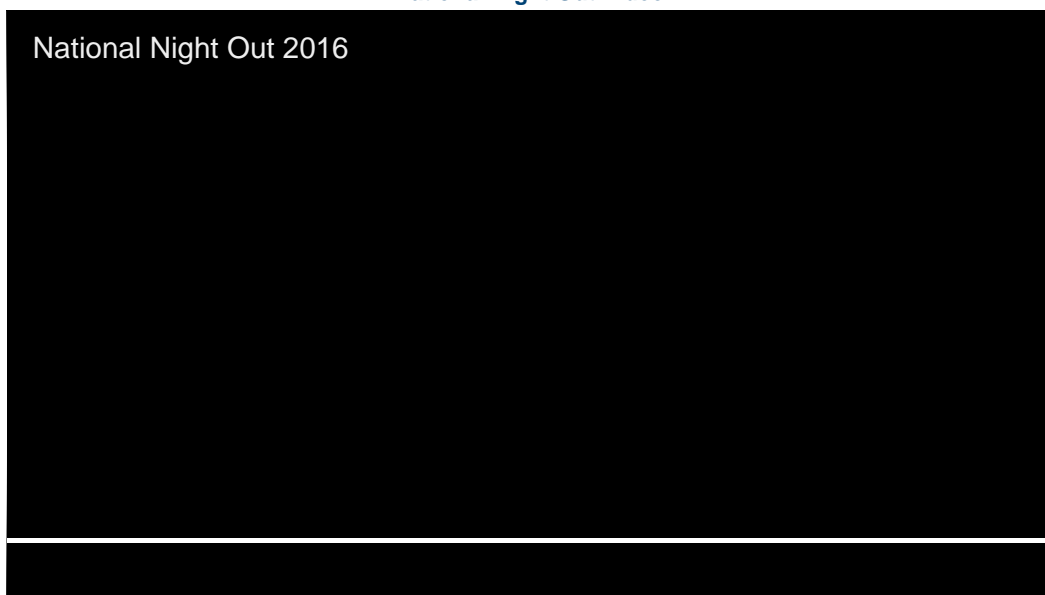

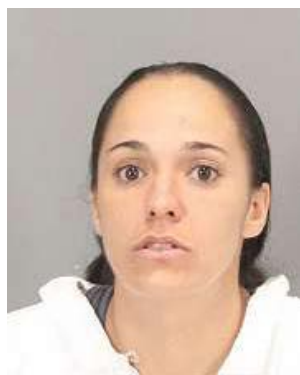

The suspect responsible for the death of Myla Thi Dang has been arrested. On July 11, 2017, suspect Zeratsion was located and arrested at the U.S.-Mexico border by U.S. Customs and Border Protection Officers. The suspect will transported back to San Jose and ultimately booked into the Santa Clara County Jail for homicide.

San Jose: On Monday, July 03, 2017 at approximately 5:07 PM, officers responded to the 600 block of S. 10th Street on report of a welfare check. The reporting party stated he heard loud bangs coming from inside the residence. Upon arrival, officers located victim Dang suffering from at least one gunshot wound. Dang was pronounced deceased at the scene.

San Jose Police Homicide Unit responded to the scene and took over the investigation. Preliminary investigation revealed the suspect and victim were known to each other. The motive and circumstances surrounding the incident are unknown. The suspect has not been located and remains at large.
