San Jose, Calif. - The San Jose Police Department's Sexual Assault Investigations Unit / Human Trafficking Task Force arrested the three listed suspects for human trafficking and other crimes.

On Sunday, May 26, 2019, at about 7:42 PM, San Jose police officers responded to the Motel 6 located at 2560 Fontaine Road in San Jose. The 14 year-old survivor reported to a crisis text hotline (741741) that she was being held against her will and forced to engage in prostitution. Patrol officers and Special Operations Division officers responded to the scene and located the survivor.

The preliminary investigation revealed the 14 year-old survivor was reported as a missing runaway from Flint, Michigan on September 1, 2018, and went to Chicago, Illinois. A few days later, the survivor was kidnapped from Chicago and taken to Gary, Indiana. Eventually, she was taken to various cities throughout California where she was forced to engage in prostitution.

Officers learned the second survivor was forced to engage in prostitution and the third survivor was procured for the purpose of

prostitution. Detectives believe the third survivor would have likely been indoctrinated into a life of prostitution had she not been rescued by the San Jose Police Department. The suspects were located at the motel and taken into custody.

Suspects Christopher Johnson and Antoine Williams were booked into Santa Clara County Jail for Human Trafficking (Felony) - 236.1 PC, Pimping and Pandering (Felony) - 266h PC / 266i PC, and Kidnapping (Felony) - 207 PC.

Suspect Curtis Russell was booked into Santa Clara County Jail for Human Trafficking (Felony) - 236.1 PC and Pimping (Felony) - 266h PC.

San Jose, Calif. - On Thursday, April 4, 2019, at about 6:48 p.m., San Jose police officers responded to the Dollar Tree Store at 1178 North Capitol Avenue in San Jose on a report of a person stabbed. Arriving officers discovered victim Ryan Rouse inside the store, suffering from at least one stab wound. The victim was transported to a local hospital where he was pronounced deceased a short time later.

The investigation revealed that police received a call on an earlier event to report seeing the victim being chased by a group of suspects. 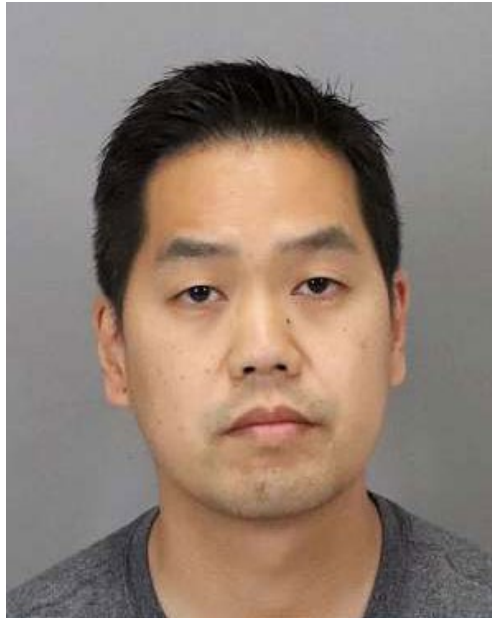

San Jose, Calif. — On Monday, May 6, 2019, at 12:01 PM, San Jose police officers responded to a purse snatch robbery in the 1500 block of Towers Lane in San Jose. The linked video shows the victim walking up a flight of stairs with her young daughter in hand. The suspect approached from behind and violently pulled the purse from the victim. The victim was dragged down the stairs along with her daughter.

Robbery detectives conducted extensive follow-up investigation and canvassed the area for witnesses and evidence. They located video surveillance of the robbery, along with a potential suspect vehicle, described as a black Lexus 4-door, leaving the area. Using the suspect's description, vehicle, and method of operation, detectives were able to link other purse snatch robberies and identified suspect Pablo Cabrera as the suspect in the video. All of Cabrera's victims were Asian females carrying expensive purses. Cabrera attacked victims from behind, grabbed their purse, and ran to his car.

On Saturday, May 11, 2019, the San Jose Police Department's Covert Response Unit apprehended Cabrera at his residence in San Jose. Detectives located additional evidence in Cabrera's home, linking him to other robberies. Cabrera was on parole for burglary. He was booked into Santa Clara County Jail for robbery and parole violation.

Chief Eddie Garcia said, "We are fortunate this predator was caught before any more members of the public were victimized. I am incredibly proud of the work of our Robbery detectives and the continued work the men and women of the San Jose Police Department do on a daily basis."

Armed Robbery / Carjacking Investigation

San Jose, Calif. — The San Jose Police Department's Robbery Unit investigated a series of armed robberies and carjackings that occurred throughout the City of San Jose between March 16, 2019 and March 29, 2019.

The investigation revealed the suspects created a fraudulent Tinder account posing as a female to communicate with male victims. The fraudulent Tinder user, with the profile names "Becky" or "Victoria," set a date and location to meet the male victims. The times and locations were usually in the late evening hours on secluded streets near a park. When the victim arrived at the location, they were beaten, robbed and carjacked at gunpoint by several masked suspects.

The five suspects were arrested on different dates and times. The adult suspects were booked into Santa Clara County Jail and the juvenile suspect was booked into Santa Clara County Juvenile Hall on multiple charges, including; robbery, carjacking, auto theft, and hit & run.

Bring your pills for disposal to the sites listed below (The DEA cannot accept liquids or needles or sharps, only pills or patches). The service is free and anonymous, no questions asked.

Last fall, Americans turned in 460 tons (more than 900,000 pounds) of prescription drugs at almost 5,800 sites operated by the DEA and more than 4,800 of its state and local law enforcement partners. Overall, in previous Take Back events, DEA and its partners have taken in almost 11 million pounds more than 5,500 tons of pills.

This initiative addresses a vital public safety and public health issue. Medicines that languish in home cabinets are highly susceptible to diversion, misuse, and abuse. Rates of prescription drug abuse in the U.S. are alarmingly high, as are the number of accidental poisonings and overdoses due to these drugs. Studies show that a majority of abused prescription drugs are obtained from family and friends, including from the home medicine cabinet. In addition, Americans are now advised that their usual methods for disposing of unused medicines flushing them down the toilet or throwing them in the trash both pose potential safety and health hazards.

San Jose, Calif. – San Jose Police Department will be conducting a DUI/Driver's License Checkpoint on 4/12/19, at an undisclosed location within the city limits between the hours of 8:00 p.m. to 2:00 a.m.

DUI Checkpoints like this one are placed in locations based on collision statistics and frequency of DUI arrests. Officers will be looking for signs of alcohol and/or drug impairment, with officers checking drivers for proper licensing.

San Jose Police Department reminds drivers that "DUI Doesn't Just Mean Booze." If you take prescription drugs, particularly those with a driving or operating machinery warning on the label, you might be impaired enough to get a DUI. Marijuana can also be impairing, especially in combination with alcohol or other drugs, and can result in a DUI.

San Jose Police Department offers these reminders to ensure you have a safe night of fun that doesn't involve a DUI:

- Always use a designated sober driver – a friend who is not drinking, ride-share, cab or public transportation – to get home.
- See someone who is clearly impaired try and drive? Take the keys and help them make other arrangements to find a sober way home.
- Report drunk drivers – Call 911.
- Hosting a party? Offer nonalcoholic drinks. Monitor who are drinking and how they are getting home.

Getting home safely is cheap, but getting a DUI is not! Drivers caught driving impaired and charged with DUI can expect the impact of a DUI arrest to be upwards of \$13,500. This includes fines, fees, DUI classes, license suspension and other expenses not to mention possible jail time.

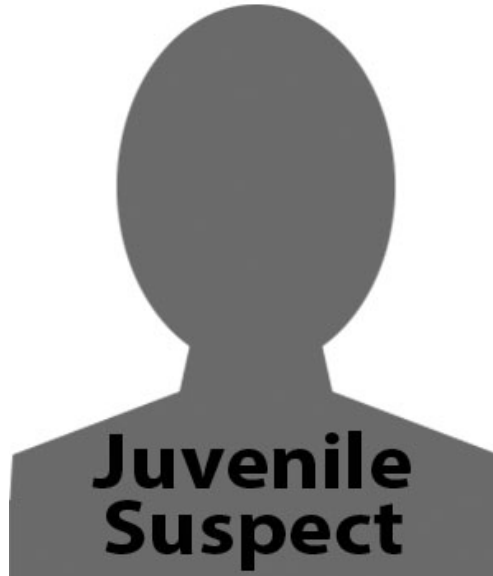

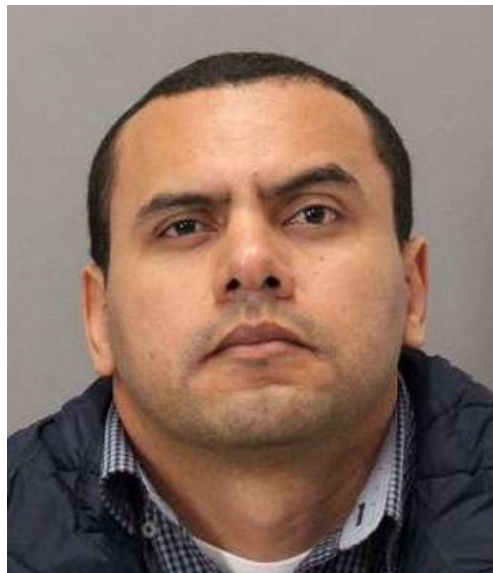

DUI/Drivers License Checkpoint Planned this Weekend

San Jose, Calif. — San Jose Police Department Traffic Unit will be conducting a DUI/Drivers License Checkpoint on December 20, 2018, at an undisclosed location within the city limits between the hours of 8:00 p.m. to 2:00 a.m.

In recent years, California has seen a disturbing increase in drug-impaired driving crashes. San Jose Police Department supports the new effort from the Office of Traffic Safety that aims to educate all drivers that "DUI Doesn't Just Mean Booze." If you take prescription drugs, particularly those with a driving or operating machinery warning on the label, you might be impaired enough to get a DUI. Marijuana can also be impairing, especially in combination with alcohol or other drugs, and can result in a DUI.

The deterrent effect of High Visibility Enforcement using both DUI checkpoints and DUI Saturation Patrols has proven to lower the number of persons killed and injured in alcohol or drug impaired crashes. Research shows that crashes involving an impaired driver can be reduced by up to 20 percent when well-publicized proactive DUI operations are conducted routinely.

DUI Checkpoints like this one are placed in locations based on collision statistics and frequency of DUI arrests, affording the greatest opportunity for achieving drunk and drugged driving deterrence. Locations are chosen with safety considerations for the officers and the public.

In California, alcohol involved collisions led to 1,155 deaths and nearly 24,000 serious injuries in 2014 because someone failed to designate a sober driver.

Officers will be looking for signs of alcohol and/or drug impairment, with officers checking drivers for proper licensing, delaying motorists only momentarily. When possible, specially trained officers will be available to evaluate those suspected of drug-impaired driving, which now accounts for a growing number of impaired driving crashes. Everyone should be mindful that if you're taking medication – whether prescription or over-the-counter – drinking even small amounts of alcohol can greatly intensify the impairment affects.

Studies of California drivers have shown that 30 percent of drivers in fatal crashes had one or more drugs in their systems. A study

of active drivers showed more tested positive for drugs that may impair driving (14 percent) than did for alcohol (7.3 percent). Of the drugs, marijuana was most prevalent, at 7.4 percent, slightly more than alcohol.

San Jose Police Department offers these reminders to ensure you have a safe night of fun that doesn't involve a DUI:

- Decide before you go out whether you plan to drink or drive. You can't do both.
- If you plan to drink, designate a sober driver before going out or map out another safe way to get home by taxi, ride-share or public transportation. You can also look up designated driver services in your area using the National Directory of Designated Driver Services (NDDDS).
- See your friend or other patron impaired trying to get behind the wheel? Take the keys and help them make other arrangements to get where they are going safely.
- Report drunk drivers – Call 911.

People are encouraged to be a part of the designated driver very important person ("DDVIP") program. As a DDVIP, you can ensure those drinking get home safely and get rewarded for it. Partnering bars and restaurants statewide have created non-alcoholic specialty drinks ("DDrinks") for sober drivers.

[Recording Artists Against Drunk Driving \(RADD\)](#) also offers a Designated Driver Rewards program at 43 college campuses statewide. Local bars and restaurants provide non-alcoholic drinks and/or food specials to DD's.

Getting home safely is cheap, but getting a DUI is not! Drivers caught driving impaired and charged with DUI can expect the impact of a DUI arrest to be upwards of \$13,500. This includes fines, fees, DUI classes, license suspension and other expenses not to mention possible jail time.

Funding for this checkpoint is provided to San Jose Police Department by a grant from the California Office of Traffic Safety, through the National Highway Traffic Safety Administration.

San Jose, Calif. - The San Jose Police Department's Special Investigations Unit conducted a large-scale operation last week, targeting a highly-organized criminal organization. The group was manufacturing and selling narcotics throughout San Jose and the Bay Area, as well as transporting narcotics across the country to the Southern and Eastern parts of the United States.

On November 28, 2018, the San Jose Police Department's Special Investigations Unit, in conjunction with the MERGE Unit; Covert Response Unit; Violent Crimes Enforcement Team; Metro Unit; ICAC Unit; K-9 Unit; Field Operations; Sunnyvale Department of Public Safety; Santa Clara County District Attorney's Office; U.S. Postal Inspectors and the U.S. Drug Enforcement Administration conducted service of six search warrants and four arrest warrants within San Jose and Sunnyvale. Over 800 pounds of marijuana, a large amount of illegal anabolic steroids, five ounces of concentrated hash oil, powder cocaine, Xanax bars, Ecstasy pills, three handguns and an expended rocket launcher (AT4) were recovered in the raids. Numerous bank accounts were also frozen and \$600,000.00 was seized. Warehouses in four other states were identified and local agencies from those respective departments acted in collaboration with the San Jose Police Department.

This operation was the culmination of a two-year long investigation. Four adult male suspects were arrested in this case and were booked into the Santa Clara County Jail for various charges, including manufacturing and transporting of narcotics and possession of illegal weapons.

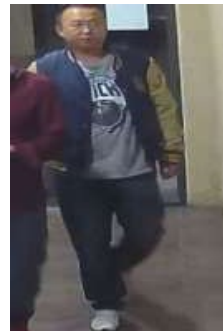

San Jose, CA — On Thursday, September 28, 2017, at approximately 8:42 PM, San Jose police officers responded to a person shot in the 300 block of Elan Village Lane in San Jose. Arriving officers located an adult male victim suffering from at least one gunshot wound. The victim was transported to a local hospital where he was pronounced deceased a short time later.

A collaborative investigation between the San Jose Police Department, Milpitas Police Department, South San Francisco Police Department and Fremont Police Department determined that there were four cases between September 27 and September 28, 2017, involving the same suspects.

All four locations were determined to be operating brothels.

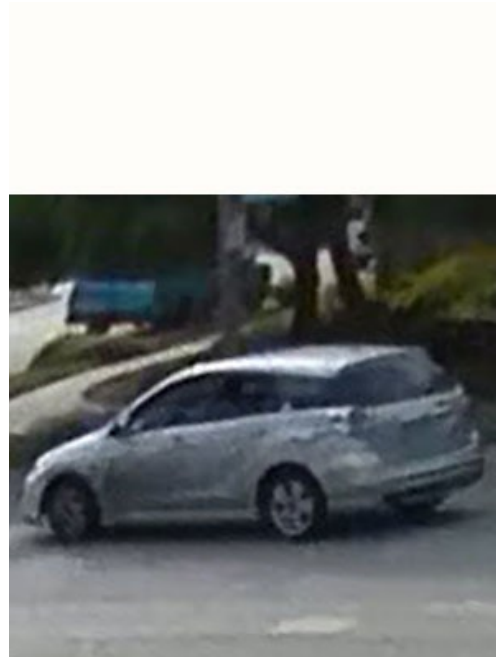

San Jose Police Department Receives Traffic Education and Enforcement Grant

San Jose, Calif. — The San Jose Police Department has been awarded a \$250,000.00 grant from the California Office of Traffic Safety (OTS) for a year-long enforcement and public awareness program. The traffic safety program is intended to educate the public on safe roadway habits and deter people from violating traffic laws or practicing other unsafe behaviors that lead to injuries and fatalities.

"Traffic Safety is our number one priority and our goal is to make it the number one priority of every driver in San Jose. This OTS Grant will help us put more Officers on the street and help us achieve this goal," said Sergeant Steven Payne.

The grant from OTS will fund various education and enforcement activities for the 2019 federal fiscal year (Oct. 1, 2018 to Sept. 30, 2019):

- DUI checkpoints and saturation patrols take suspected alcohol/drug-impaired drivers – and those unlicensed or with a revoked/suspended license – off the road.
- Traffic safety education presentations for youth and community members on distracted, impaired and teen driving, and bicycle/pedestrian safety.
- Patrols at intersections with increased incidents of pedestrian and bike collisions.
- Checking for seat belt and child safety seat compliance.
- Motorcycle safety operations in areas with high rider volume and where higher rate of motorcycle crashes occur.
- Speeding, red light and stop sign enforcement.
- Compilation of DUI "Hot Sheets" identifying repeat DUI offenders
- Specialized DUI and drugged driving training to identify and apprehend suspected impaired drivers.

In 2016, 3,623 people were killed in crashes across the state, a 7 percent increase from 2015, according to the [National Highway](#)

Traffic Safety Administration. Particularly alarming is the rise in pedestrian deaths, with 867 pedestrians killed on California roadways in 2016, a nearly 33 percent increase from 2012. Along with the growing dangers of distracting technologies like phones and drug-impaired driving, this grant funding will provide opportunities to combat these dangerous and illegal behaviors.

"Almost all crashes are preventable," OTS director Rhonda Craft said. "Education and enforcement go hand in hand helping change behaviors that cause devastating crashes."

Funding for this program is provided by a grant from the California Office of Traffic Safety, through the National Highway Traffic Safety Administration.

San Jose, CA - On Saturday, October 27th, 2018, from 10:00 AM to 2:00 PM, the **San Jose Police Department** and the Drug Enforcement Administration (DEA) will give the public another opportunity to prevent pill abuse and theft by ridding their homes of potentially dangerous expired, unused, and unwanted prescription and over the counter drugs. Bring your pills for disposal to the sites listed below (The DEA cannot accept liquids or needles or sharps, only pills or patches). The service is free and anonymous, no questions asked.

In October 2017, Americans turned in 450 tons (900,000 pounds) of prescription drugs at almost 5,500 sites operated by the DEA and more than 4,200 of its state and local law enforcement partners. Overall, in previous Take Back events, DEA and its partners have taken in over 8.1 million pounds more than 4,050 tons of pills.

This initiative addresses a vital public safety and public health issue. Medicines that languish in home cabinets are highly susceptible to diversion, misuse, and abuse. Rates of prescription drug abuse in the U.S. are alarmingly high, as are the number of accidental poisonings and overdoses due to these drugs. Studies show that a majority of abused prescription drugs are obtained from family and friends, including from the home medicine cabinet. In addition, Americans are now advised that their usual methods for disposing of unused medicines flushing them down the toilet or throwing them in the trash both pose potential safety and health hazards.

San Jose, Calif. - The San Jose Police Department has established a new **Burglary Prevention Unit (BPU)** as a proactive unit within the Bureau of Investigations that will utilize specialized investigative techniques to target the most active and prolific criminals in the City of San Jose.

BPU will be responsible for the investigation and apprehension of individuals or groups involved in property related crimes with a focus on burglaries and thefts, but the scope may vary based on investigative needs. BPU will work with other SJPd units, Bay Area law enforcement agencies, and the Santa Clara County District Attorney's Office Crime Strategies Unit.

BPU will use data driven analytics to target areas of San Jose that are experiencing high burglary rates; will work closely with the San Jose PD Financial Crimes Unit to recognize and focus on burglary crews, trends and burglary strings; and will inspect and enforce pawn shop regulations.

San Jose, Calif. - On Thursday, August 30th, 2018, at approximately 1:56pm, San Jose police officers responded to a person shot in the area of Havana Drive and Tampa Way in San Jose. Arriving officers found the juvenile victim had already been transported to a local hospital suffering from at least one gunshot wound. The victims injuries were determined to be non-life threatening.

Preliminary investigation revealed that two adult male suspects confronted the victim. Both suspects produced handguns and fired multiple rounds at the victim, striking him at least once. Patrol officers developed leads at the scene and worked collaboratively with detectives from the Gang Investigations Unit (GIU). Ultimately, detectives from GIU identified both suspects and obtained arrest warrants for Attempted Murder- 664/187 PC (felony).

On September 13th, 2018, the San Jose Police Department's Covert Response Unit (CRU) located suspect #1, Marco Alanis at a residence on Midfield Drive in San Jose. Alanis was taken into custody as he attempted to flee over the backyard fence.

Later that same day, CRU located suspect #2, Robert Aguirre at a residence on Ezie Street in San Jose. Aguirre also attempted to flee over a backyard fence and was taken into custody with the assistance of a San Jose police canine. Officers found Aguirre in possession of a handgun at the time of his arrest.

Suspect #3, Caesar Cortez, wanted on an unrelated robbery warrant, refused to exit the residence. The MERGE Unit was called to assist. Several hours later, Cortez exited the residence and was taken into custody without incident. Detectives located an additional handgun and a high powered rifle inside the residence. All three suspects were booked into Santa Clara County Jail.

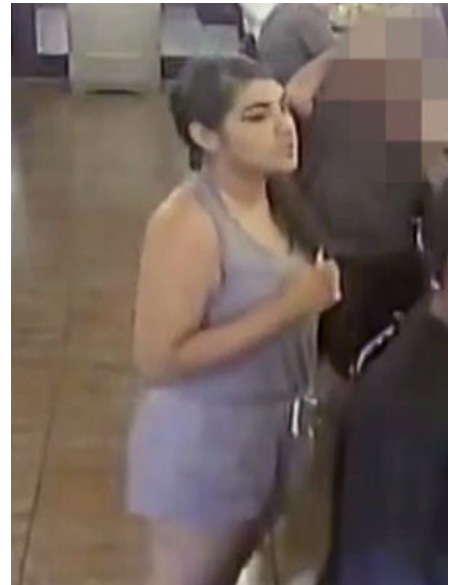

DUI/Drivers License Checkpoint Planned this Week

San Jose, Calif. - The San Jose Police Department Traffic Unit will be conducting a DUI/Drivers License Checkpoint on August 30th, at an undisclosed location within the city limits between the hours of 8:00 p.m. to 2:00 a.m.

In recent years, California has seen a disturbing increase in drug-impaired driving crashes. San Jose PD supports the new effort from the Office of Traffic Safety that aims to educate all drivers that "DUI Doesn't Just Mean Booze." If you take prescription drugs, particularly those with a driving or operating machinery warning on the label, you might be impaired enough to get a DUI. Marijuana can also be impairing, especially in combination with alcohol or other drugs, and can result in a DUI.

The deterrent effect of High Visibility Enforcement using both DUI checkpoints and DUI Saturation Patrols has proven to lower the number of persons killed or injured in alcohol or drug impaired crashes. Research shows that crashes involving an impaired driver can be reduced by up to 20 percent when well-publicized proactive DUI operations are conducted routinely.

DUI Checkpoints like this one are placed in locations based on collision statistics and frequency of DUI arrests, affording the greatest opportunity for achieving drunk and drugged driving deterrence. Locations are chosen with safety considerations for the officers and the public.

In California, alcohol involved collisions led to 1,155 deaths and nearly 24,000 serious injuries in 2014 because someone failed to designate a sober driver.

Officers will be looking for signs of alcohol and/or drug impairment, with officers checking drivers for proper licensing, delaying motorists only momentarily. When possible, specially trained officers will be available to evaluate those suspected of drug-impaired driving, which now accounts for a growing number of impaired driving crashes.

Studies of California drivers have shown that 30 percent of drivers in fatal crashes had one or more drugs in their systems. A study of active drivers showed more tested positive for drugs that may impair driving (14 percent) than did for alcohol (7.3 percent). Of the drugs, marijuana was most prevalent, at 7.4 percent, slightly more than alcohol. Everyone should be mindful that if you're taking medication, whether prescription or over-the-counter, drinking even small amounts of alcohol can greatly intensify the impairment affects.

Drivers are encouraged to download the Designated Driver VIP, or “DDVIP,” free mobile app for Android or iPhone. The DDVIP app helps find nearby bars and restaurants that feature free incentives for the designated sober driver, from free non-alcoholic drinks to free appetizers and more. The feature-packed app even has social media tie-ins as well as a tab for the non-DD to call Uber, Lyft or Curb.

Drivers caught driving impaired can expect the impact of a DUI arrest to include jail time, fines, fees, DUI classes, license suspensions and other expenses that can exceed \$10,000, not to mention the embarrassment when friends and family find out.

This Labor Day, and Every Day: Drive Sober or Get Pulled Over

San Jose, Calif. — As we enter the final stretch of summer, spending time at the pool or barbecuing with friends and family, San Jose Police Department is driving home the importance of celebrating responsibly by not driving or riding a motorcycle, while impaired.

From Aug. 17 through Sept. 3, San Jose Police Department is participating in a high-visibility national enforcement campaign, Drive Sober or Get Pulled Over. During this period, Police and Sheriff's Departments statewide, along with the California Highway Patrol, will increase the number of officers on the road to stop suspected drunk or drug impaired drivers and motorcyclists. If you are caught driving or riding impaired, you will be pulled over and arrested.

The enforcement campaign runs through the Labor Day holiday weekend, which is one of the deadliest times of the year in terms of alcohol-involved traffic deaths. Sadly, one-third of all traffic deaths involved drunk drivers. According to the National Highway Traffic Safety Administration (NHTSA), 10,497 people were killed in alcohol-involved crashes, or one person every 50 minutes.

The San Jose Police Department will show zero tolerance for impaired driving or riding and joins efforts by the California Office of Traffic Safety (OTS) to educate drivers that "DUI Doesn't Just Mean Booze." If you take prescription drugs, particularly those with a driving or operating machinery warning label, you may be impaired enough to get a DUI. Marijuana can also be impairing and result in a DUI, especially in combination with alcohol or other drugs.

In the ten years from 2005-2015, the percentage of drivers in fatal crashes with an impairing drug other than alcohol in their system has risen from 26.2 percent to 42.6 percent. As far back as 2012, a roadside survey in California showed more drivers tested positive for drugs that may impair driving (14 percent) than did for alcohol (7.3 percent).

During this national enforcement campaign, there will also be increased state and national messages about the dangers of riding impaired, which combined with enforcement, aims to drastically reduce drunk or drug impaired riding on our nation's roadways.

Motorcycles require specific training and skill. When a rider adds alcohol, marijuana or impairing prescription medication to the mix,

it is not only illegal, but increases the risky nature of riding a motorcycle.

There are so many options out there to get home safely. There is no excuse for getting behind the wheel when you are impaired.

To avoid a DUI and putting others, and yourself, at risk, San Jose Police Department has a few tips to stay safe on the roads:

- Always designate a sober driver.
- Use public transportation or a ride sharing service to get home. Have a friend or family member who is about to drive buzzed or impaired? Take the keys away and make arrangements to get them home safely.
- Report drunk drivers - call 911.
