On October 16th, 2020 at approximately 11:40pm, Officers responded to the Nuevo Vallarta restaurant located in the 100 block of S. Captiol Avenue for a shooting incident. When they arrived, they located five victims, all adult males. They all suffered from at least one gunshot wound each. One of the victims was declared deceased at the scene by paramedics. A second was transported to a local hospital where he succumbed to his injury and was pronounced deceased.

Three other victims were transported to local hospitals where they are being treated for non-life-threatening injuries. During the investigation a sixth victim arrived at a local emergency room. He was identified as being present at the scene and also had a non-life-threatening injury. All are expected to survive.

There are currently no suspects identified or apprehended. The motive and circumstances surrounding the incident are under investigation.

The identity of the victims will be released by the Santa Clara County Coroner's Office after confirming the victim's identity and notifying next of kin.

These are the City's 34th and 35th homicides of 2020.

National Prescription Drug Take Back Day

San Jose, CA - On Saturday, October 24th, 2020, from 10:00 AM to 2:00 PM, the **San Jose Police Department** and the Drug Enforcement Administration (DEA) will give the public another opportunity to prevent pill abuse and theft by ridding their homes of potentially dangerous expired, unused, and unwanted prescription and over the counter drugs. Bring your pills for disposal to the sites listed below (The DEA cannot accept liquids or needles or sharps, only pills or patches). The service is free and anonymous, no questions asked.

Last fall, Americans turned in 460 tons (more than 900,000 pounds) of prescription drugs at almost 5,800 sites operated by the DEA and more than 4,800 of its state and local law enforcement partners. Overall, in previous Take Back events, DEA and its partners have taken in almost 11 million pounds more than 5,500 tons of pills.

This initiative addresses a vital public safety and public health issue. Medicines that languish in home cabinets are highly susceptible to diversion, misuse, and abuse. Rates of prescription drug abuse in the U.S. are alarmingly high, as are the number of accidental poisonings and overdoses due to these drugs. Studies show that a majority of abused prescription drugs are obtained from family and friends, including from the home medicine cabinet. In addition, Americans are now advised that their usual methods for disposing of unused medicines flushing them down the toilet or throwing them in the trash both pose potential safety and health hazards.

SJPD Begins Reimagining Mental Health Crisis Response

This week San Jose Police launched a new pilot program in collaboration with the County of Santa Clara Department of Behavioral Health pairing San Jose Police Officers and clinicians to more rapidly assist individuals in a mental health crisis.

Officers in the program are dressed in a special uniform, receive additional mental health and de-escalation training, and respond to calls with the county's MCRT (Mobile Crisis Response Team).

The program will utilize enhanced referrals that better connect social services and community organizations to people who are experiencing a mental health crisis or may not have reached a crisis level. Goals include improving outcomes for individuals with mental illness, redirecting the mentally ill away from the criminal justice system and to the appropriate system of care.

"People are experiencing a mental health crisis in alarming numbers, and this partnership will get help there faster. We have been working for a long time to build a better system that integrates county health with police response. This partnership is a giant first step in improving outcomes and reimagining approaches to mental health crisis" - Chief Eddie Garcia.

Responding to in-progress calls with officers, clinicians will help de-escalate and resolve emergencies, minimizing police intervention. The teams of officers and clinicians will also conduct home visits through county referrals, identify people frequently in mental health crises, and connect them with services before we receive a 911 call.

"I applaud Chief Eddie Garcia and his team for their persistent, multi-year efforts to enlist County staff in a partnership that will enable us to respond to calls of severe emotional distress with someone bearing a psychology degree and empathetic ear rather than a gun and a badge." - Mayor Sam Liccardo

"Partnerships like this can remove barriers that sometimes prevent the people most in need from getting the care they deserve." - Cindy Chavez, President of the Santa Clara County Board of Supervisors.

The one-year pilot program is funded through a 2018 Department of Justice grant and has been in development for the past year. It includes two Officers and a supervisor in the field, two days a week.

On September 4th, 2020 at approximately 3:14pm, Officers responded to the area of Blossom Hill Road and Coyote Road to investigate a collision involving a vehicle and a bicyclist. The preliminary investigation revealed the following:

The San Jose Police Department supports community members constitutional right to peacefully protest; however, when acts of vandalism and arson occur, we will conduct thorough investigations to identify and ultimately arrest those responsible.

On August 28th, 2020 at approximately 10:00 PM, a group of protestors gathered outside of a residence in San Jose. Several of the protestors participated in acts of vandalism targeting the residence and damaged it. After an extensive follow up investigation by detectives, suspect Hailey Scimone was identified and arrested for her role in the vandalism. She was taken into custody on October 3rd in the city of Santa Clara and booked into the Santa Clara County jail for felony vandalism.

We are currently asking for the public's help in identifying an additional suspect wanted for their role in vandalism at the residence. Images are included. The suspect is described as a female, in her early 20's, medium build, long brown hair, wearing a black shirt, white shorts and vans style shoes.

On September 23rd, 2020 at approximately 9:00 PM, a group of protestors gathered at the Thomas Fallon monument in the area of Julian Street and Highway 87. During the gathering the monument was defaced with spray paint and set on fire with an accelerant. San Jose Fire Department personnel responded and extinguished the fire. Suspects Daniel Barrera and Jesilyn Faust were identified and arrest warrants were issued. Barrera and Faust were taken into custody on October 2nd in San Jose and subsequently booked into the Santa Clara County jail for felony vandalism and arson.

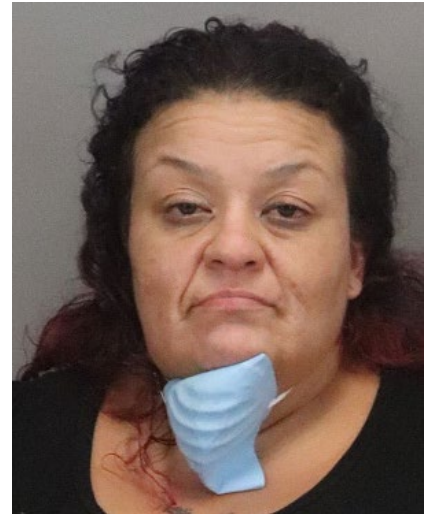

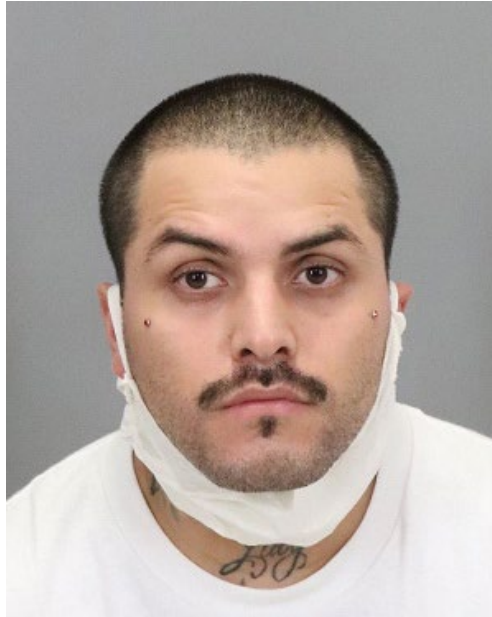

SJPD Release of Body Worn Camera Footage of incidents of significant interest

Today we are releasing BWC (body worn camera) footage of three incidents that we consider to be events of extraordinary public interest. We understand there is a heightened desire by the public to see BWC in cases that are widely circulated on-line and covered by media outlets.

We currently release BWC footage for incidents as required by state legislation. We have rarely released BWC in cases not required by legislation, where there is pending litigation or when there are ongoing investigations that could be impacted.

We understand we need to make some amount of BWC footage available to the public that goes beyond what is required; the three videos released today are the types of cases where we want to expand beyond what is required be as transparent as possible. This is the first step towards that goal.

Statement from Chief Garcia:

"We hope releasing these videos will provide the public more clarity into each of these incidents. Each video is only one piece of information used to fully understand a complex event. Some opinions and conclusions may be affected after watching certain videos; others will not."

What may have looked like a motorcycle officer intentionally hitting a person in cell phone video was, in fact, a traffic collision after a fleeing suspected ran in front of that motorcycle.

In another video, we see the offensive and completely unacceptable language used by an Officer that undermined the countless other officers navigating the same challenging circumstances but acting professionally.

Body-worn camera video is an essential component in investigations and in maintaining the public trust. The decision to release these videos today has been a collaboration with the City Manager and the Mayor. Coming up with a process of releasing videos of significant public interest is the right thing to do and we are eager to have that in place soon. Releasing these three videos is a positive step in that direction."

The following videos include multiple camera angles and pre-arrest footage of 10 minutes except incident #1 as it was a rapidly unfolding event capturing only 1 minute 22 seconds prior to the collision.

Incident 1) Case number 20-152-0358 (Pedestrian versus Traffic Unit Motorcycle)

On Sunday, May 31st at approximately 9:30 PM, Officers were in the downtown area during large protests. Officers received a call of possible looting and an attempted commercial burglary at the Bank of America branch at South Fourth and San Fernando Streets.

Officers attempted to detain multiple suspects seen in the area of the bank who they believed were possibly armed with weapons or tools that were utilized to remove plywood from the front of the bank. All indications were that the group was engaging in an attempted commercial burglary of the bank, a felony in California. One of the suspects fled from Officers on foot, he ran in a zig-zag manner northbound on Fourth Street. The fleeing subject was wanted for suspected involvement in a felony commercial burglary.

He was on the sidewalk on the west side of the street. SJPD Traffic Unit Officers on motorcycles were simultaneously riding northbound parallel to the suspect. During the foot chase a foam baton round was fired at and stuck the suspect in his lower body.

The suspect then made a sudden sharp right turn into the street, with Officers still pursuing him, and ran into the lanes of traffic where the Motor Officers were traveling. He ran directly into the path of a motorcycle, the Officer attempted emergency braking but was not able to stop his motorcycle from colliding with the suspect.

The suspect was taken into custody after the collision. You can hear the suspect ask for medical attention on the video, County EMS medical was called to the scene but the suspect changed his mind and refused medical treatment.

Officers transported the suspect to the command center for processing.

The collision in this incident was found to be a traffic collision, and not a legal intervention or use of force. A traffic collision investigation was completed for the incident.

Following the incident, Officers inspected the damage to the bank. Protesters had removed sections of the boarded windows attempting to enter the bank.

Incident 2 Case Number 20-150-0495 (Subject attempting to disarm Officer/Failing to disperse)

On Friday , May 29th at approximately 3:00 PM, protests began to turn violent in the eastern part of the city, in particular the area of Highway 101 and Alum Rock Avenue. Protesters walked onto the freeway and temporarily halted traffic. As the afternoon went on protesters began to gather in the area of City Hall located on Santa Clara Street. The crowd numbered in the hundreds and possibly over 1,000.

Officers were mobilized from all over the city and responded to deal with the unrest. It should be noted that numerous objects were thrown at Officers in an assaultive manner; some of the objects were large rocks, frozen plastic water bottles, and glass bottles just to name a few. At approximately 5:00 pm a dispersal order was given and declared the gathering an unlawful assembly. The order was broadcast via a long range acoustic device and was repeated for the duration of the event.

One group of Officers formed a line by standing next to each other in a attempt to control the crowd. The subject depicted in this video can be seen from several different angles approaching the line of Officers, clearly not dispersing from the scene. He got close enough to the line that one Officer was forced to use an approved crowd control technique and pushed the subject back utilizing his wooden baton by holding it horizontal to the ground and pushing the subject away. A physical confrontation ensued and the subject subsequently attempted to disarm the Officer by pulling on his baton. Attempting to disarm an Officer is a misdemeanor crime per

California penal code section 148(b). This image is clearly visible in a still frame from the Officer's BWC. The subject then began to swing wildly at the Officer with his arms in a striking motion. Other Officers immediately ran over to assist and attempted to subdue the subject. The physical confrontation continued until the subject was wrestled to the ground and was eventually subdued and placed into handcuffs.

The subject sustained injuries as a result of the confrontation and was transported to a nearby hospital for treatment.

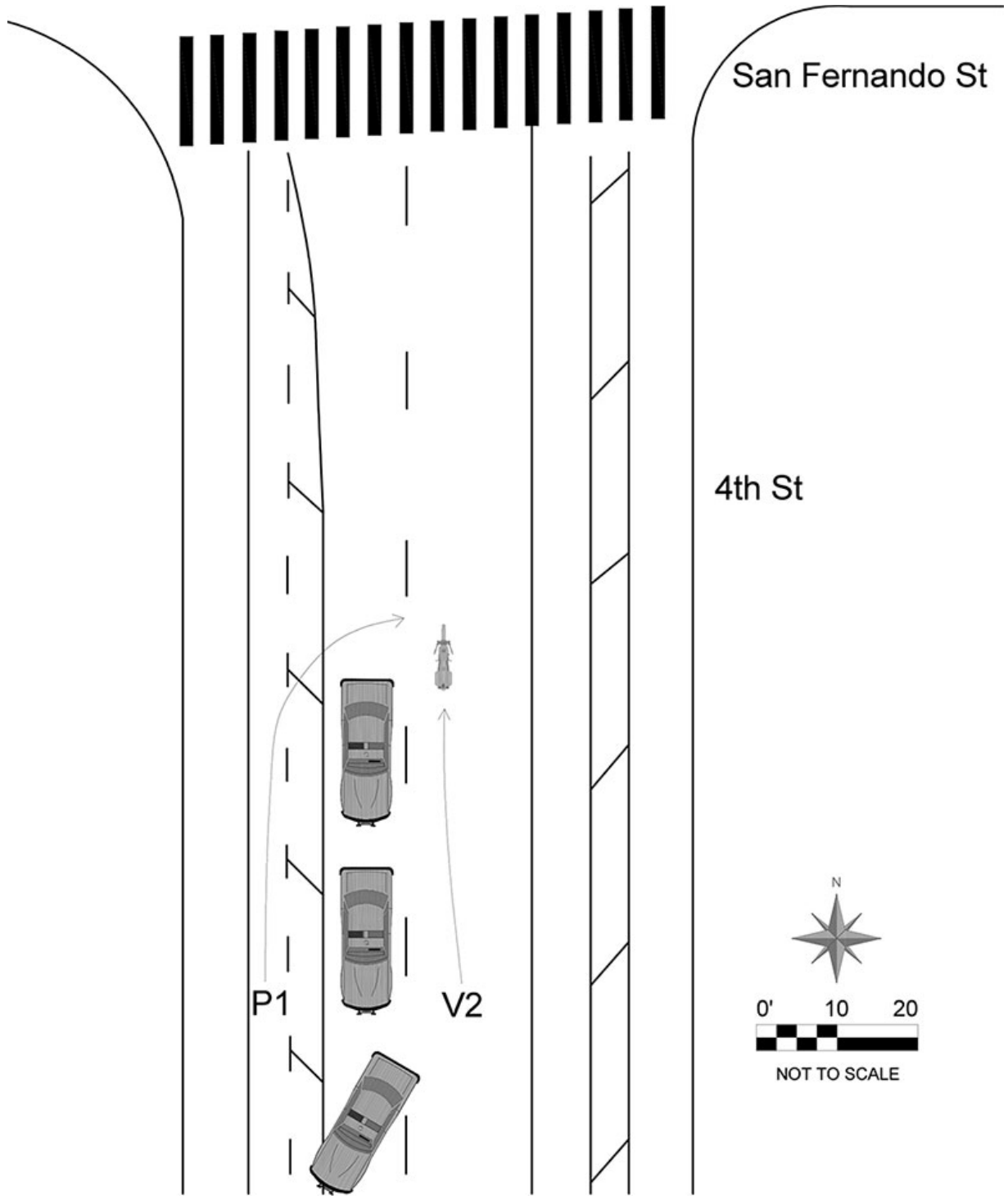
Incident 3 Case Number 20-150-0495 (Foam Baton deployment/Attempted arrest of felon)

Related to incident #2, on the same date at approximately 5:45 PM, another team of Officers was dealing with a hostile crowd at San Jose City Hall. Members of the Special Operations Division were deployed alongside Patrol Officers. A suspect was identified that had thrown a bottle at an Officer; he is depicted in the video wearing a white T-shirt and a white mask covering his face.

Officers can be heard formulating a plan on how and when to arrest the suspect for the bottle throwing, a crime classified as a felony and covered under California Penal Code Section 245(c). A foam baton round is fired at the subject prior to effecting the arrest; after being struck by the foam baton round the suspect immediately turns and flees on foot and is not apprehended. Because of his escape Officers were not able to evaluate or ascertain if the suspect received any injuries as a result of the foam baton strike.

This video depicts the Officer using offensive and unacceptable language during the protest.

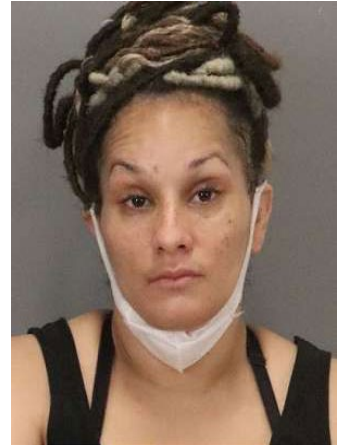

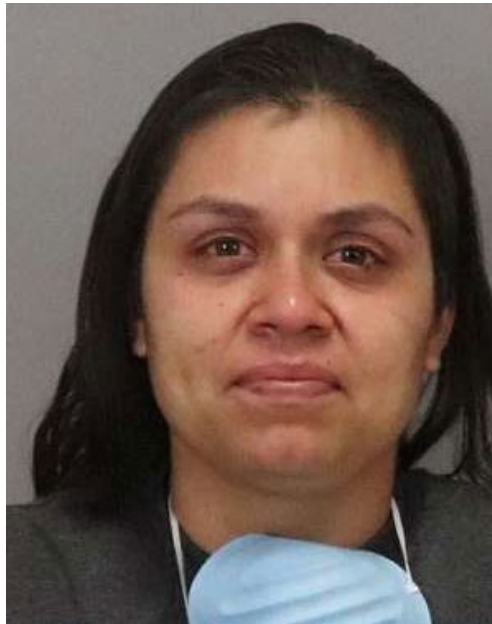

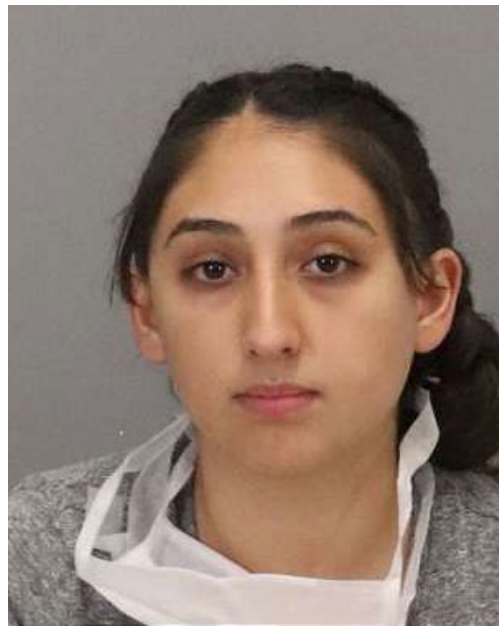

SJPD Gang Investigations Unit Operation

San Jose, Calif. - Since April 2020, the San Jose Police Department's Gang Investigations Unit (GIU) conducted an extensive investigation of suspects associated with gangs for possessing firearms and other crimes.

On Wednesday, May 20, 2020, and Thursday, May 21, 2020, GIU detectives, with the Santa Clara County District Attorney's Office, utilized the assistance of MERGE, Covert Response Unit, Street Crimes, Metro, Violent Crimes Enforcement Team, patrol, and Santa Clara County Adult Probation to serve a total of thirteen search warrants in San Jose and one in the City of Milpitas. The eight listed suspects were arrested and booked into Santa Clara County Jail on various charges including child endangerment, felon in possession of a firearm, felon in possession of ammunition, possession of narcotics for sale, possession of illegal weapons, and probation violation.

The following items were seized as evidence:

- 6 firearms (1 stolen)
- Brass knuckles
- Ammunition
- Narcotics (controlled substances, mushrooms, marijuana)
- Approximately \$26K cash associated to narcotic sales

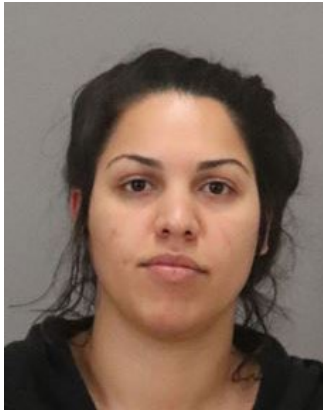

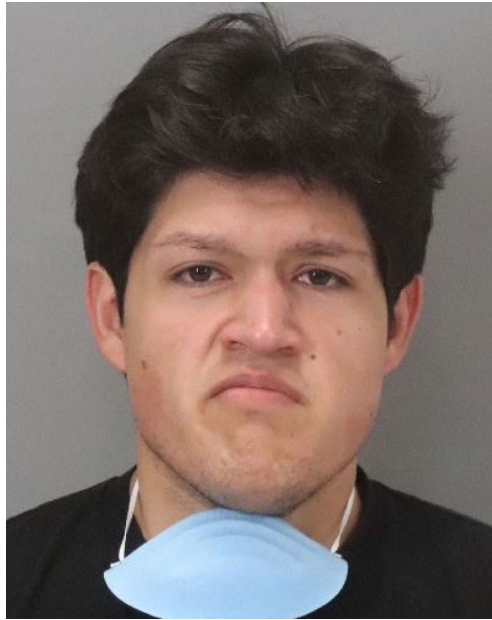

San Jose, Calif. - The San Jose Police Department's Internet Crimes Against Children (ICAC) Task Force/Child Exploitation Detail (CED) arrested suspect Estevan Gerardo Carrillo for possession of child pornography - 311.11(C) PC (felony).

SJPD Officers Arrest Multiple Suspects in 6-Day Period for Illegal Weapons & Drugs

San Jose police officers arrest multiple suspects for weapons and narcotic offenses in a 6 day period.

San Jose, Calif. — 20-122-0866 (OIS #2): On Friday, May 1, 2020, officers from our Violent Crimes Enforcement Team (VCET) were on patrol in support of the Cinco de Mayo weekend activities. VCET officers observed a vehicle in the area of E. San Antonio St. and Oakland Rd. They recognized the driver as a known gang member. VCET officers had information that the driver was in possession of a firearm. Officers observed the driver commit vehicle code violations and attempted to stop him. However, he fled the area in his vehicle before officers could initiate the stop. A second male passenger was also in the vehicle.

Moments later, officers spotted the driver on foot near E. San Antonio St. and King Rd. He was with a male later identified as suspect Cristoban Martinez-Lima. Both subjects are known gang members. The two subjects split up and walked away in separate directions. Officers contacted the driver on Whitton St. near King Rd. He was cooperative, interviewed and released pending review for criminal charges by the District Attorney's Office.

VCET officers initiated a pedestrian stop on Martinez and he immediately fled. As Martinez fled, he reached into his waistband and pulled a semiautomatic firearm. As Martinez pulled the firearm, his body turned to the right and looked over his shoulder in the direction of the VCET officer. The officer saw the gun and perceived the movement as an imminent attack and fired a single shot from his department issued handgun at Martinez. Martinez was not hit and was taken into custody. The .45 caliber firearm, which was in the suspect's possession, was later recovered by officers. The suspect was booked into Santa Clara County Jail.



20-124-0835: On Sunday, May 3, 2020, officers with the San Jose Police Department's Violent Crimes Enforcement Team observed a vehicle collide into a guardrail and then continue driving. Officers were able to stop the vehicle in the area of San Antonio St. and Highway 101 overpass. The driver of the vehicle fled on foot into nearby bushes. Officers were able to detain the suspect without incident. The suspect is a known gang member. A search was conducted in the area and a loaded 9MM handgun with a high capacity magazine was located. The suspect was booked into Santa Clara County Jail.



20-125-0199: On Monday, May 4, 2020, METRO officers executed a search warrant on a prior convicted felon involved in selling large quantities of narcotics in the City of San Jose. The suspect was taken into custody without incident and a search of the residence was completed. The suspect was found to be illegally in possession of 2 firearms, 2 pounds of crystal methamphetamine, 147 grams of powder heroin, 54 grams of cocaine, 36 grams of black tar heroin, and approximately \$13,000 in cash. The suspect was booked into Santa Clara County Jail.



On Wednesday, May 6, 2020, Metro officers conducted a follow-up search warrant associated to the above case. Two additional illegally possessed handguns, a shotgun, and ammunition were discovered at the location.



20-127-0707: On Wednesday, May 6, 2020, officers from the San Jose Police Department's Street Crimes Unit conducted a parole search at an address on Carnelian Dr. in San Jose. 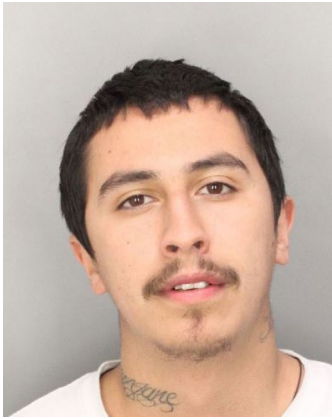

San Jose, Calif. - On Saturday, October 26, 2019, at approximately 5:26 PM, the San Jose Police Department received a call of a person shot in the area of North 5th Street at East Santa Clara Street in San Jose. Upon arrival, officers located two adult males suffering from at least one gunshot wound each. The victims were transported to a local hospital. Victim Wilmar Spikes was pronounced deceased shortly after arriving at the hospital. Victim 2 sustained non-life-threatening injuries.

On February 11, 2020, Suspect #4, Alberto Hernandez, was arrested by the Santa Clara County Sheriff's Office while he was at Santa Clara County Superior Court on an unrelated case. Hernandez had an arrest warrant for conspiracy and was subsequently booked into Santa Clara County Jail.

On April 30, 2020, the fifth and final suspect, Samuel Arroyo, was arrested in San Jose by the San Jose Police Department's MERGE Unit and booked into Santa Clara County Jail for conspiracy. All suspects remain in custody.

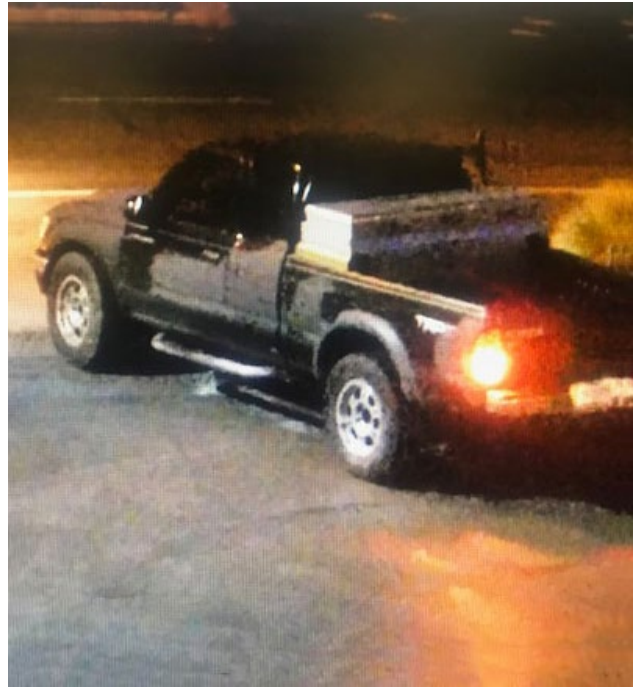

New SJPD / YWCA partnership campaign aims to stop the spread of domestic violence and child sexual abuse during COVID-19.

On Thursday, April 23, 2020, a new series of public service videos, co-produced between the YWCA and SJPD, will use paid ads on social media platforms funded through a YWCA grant. In addition to running the PSAs, we will target additional paid ads to areas where we see spikes in reported abuse.

The PSAs contain messages for abusers, adult and child victims highlighting the resources for survivors that continue to be available during the shutdown and the consequences for abusers from a criminal justice system that remains fully operational.

San Jose Police Chief Eddie Garcia said, "While we have not seen spikes in these crimes as of yet, we would like to be proactive in our approach. We know being sheltered at home may not be a safe place for everyone, so it's important that we let our community know abuse will not be tolerated and all the systems are still in place to assist anyone being harmed at home."

Tanis Crosby, CEO of YWCA Silicon Valley said, "It can be difficult sometimes to let yourself believe that you are experiencing domestic violence – because you love and depend on your partner, and you might be scared about what life might be like without them. This campaign highlights that just like COVID-19, the signs of domestic violence and sexual assault aren't always clear to others or even ourselves. We want to make sure our community knows that the YWCA is here to support you. Contact the YWCA, 24/7 and connect with a confidential advocate. We are here to help – during this pandemic and always."
